A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING A TASK ORDER UNDER THE CITY'S RIGHT OF WAY IMPROVEMENTS CONTRACT (ITB 22-010) WITH CHARLEY TOPPINO & SONS, INC. IN A TOTAL AMOUNT NOT TO EXCEED \$202,199.61 FOR FRANCES STREET/JAMES STREET ADA SIDEWALK CONNECTIVITY PROJECT, INCLUDING ADA COMPLIANT SIDEWALKS, GRAVEL SHOULDERS AND PAVEMENT MARKINGS ON FRANCES STREET AND JAMES STREET; AUTHORIZING ANY NECESSARY BUDGET ADJUSTMENTS; AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 22-289, the City Commission awarded ITB #22-010, for Right of Way Improvements Contract, to provide paving services and sidewalk improvements, including gravel shoulders, along City rights-of-way to Charley Toppino & Sons, Inc.; and

WHEREAS, City staff recommends approval of a Task Order to install ADA sidewalks, gravel shoulders and pavement markings on Frances Street and James Street to improve safety and appearance; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the attached Task Order under the City's Right of Way Improvements Contract (ITB 22-010) with Charley Toppino & Sons, Inc. in a total amount not to exceed \$202,199.61, for the Frances Street/James Street ADA Sidewalk Connectivity Project, including installation of ADA sidewalks, gravel shoulders and pavement markings on Frances Street and James Street, is hereby approved.

Section 2: That funding is budgeted for the Frances and James Street ADA Sidewalk Connectivity Project in Infrastructure Project account II4102201 - FY 23. Any necessary budget transfers or adjustments are hereby authorized.

Section 3: That the City Manager or designee is authorized to execute any necessary documents for this project, upon consent of the City Attorney.
