A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AUTHORIZING THE PURCHASE OF SIX (6) MWI SEA316 STAINLESS STEEL SUBMERSIBLE ELECTRIC PUMPS TO BE INSTALLED IN STORMWATER PUMP STATIONS IN THE AMOUNT OF \$797,376.00 TECHNOLOGIES, FROM PSI PURSUANT TO SECTION 2-797(1) OF THE CITY'S ORDINANCES; AUTHORIZING THE MANAGER, OR DESIGNEE, TO EXECUTE NECESSARY RELATED DOCUMENTS AND BUDGET TRANSFERS/ADJUSTMENTS, UPON CONSENT OF THE CITY ATTORNEY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Key West operates and maintains five (5) stormwater pump stations that are designed to be equipped with two (2) submersible pumps. The second pump serves as a backup pump and as the peak flow supplement pump for use during tropical storms and hurricanes. Currently two (2) stations are operating with only one (1) pump, and the pumps in the other stations are nearing the end of useful life and will need to be replaced this year; and

WHEREAS, the estimated delivery time for purchase of an MWI stainless steel submersible electric pump is thirty-four (34) weeks. The City's purchase of the MWI SEA316 stainless steel submersible electric pumps is necessary to keep the stormwater pump stations in operation when pumps are being repaired or replacement is necessary; and

WHEREAS, pursuant to 2-797(1) of the City's Code of Ordinances, when the department head makes a written determination, and the purchasing agent verifies, that there is

only one source for the commodity and the cost exceeds \$50,000.00, the City Commission may authorize the sole source procurement; and

WHEREAS, funds to purchase six (6) MWI SEA316 stainless steel submersible electric pumps are available in Account No. 4023803-5384600- Renewal and Replacement Stormwater Utility Fund and a budget transfer within the stormwater fund will be necessary; and

WHEREAS, the City Manager's Office recommends the Mayor and City Commission approve the purchase of six (6) MWI SEA316 stainless steel submersible electric pumps to be installed in the City's stormwater pump stations, in the amount of \$797,376.00, from PSI Technologies, Inc., pursuant to Section 2-797(1) of the City's Code of Ordinances;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the Commission, pursuant to Section 2-797(1). of the City's Code of Ordinances and finding it in the best interest of the City, hereby authorizes the purchase of six (6) MWI SEA316 stainless steel submersible electric pumps to be installed in the City's stormwater pump stations in the amount of \$797,376.00, from PSI Technologies, Inc. to be paid from Account No. 4023803-5384600- Renewal and Replacement Stormwater Utility Fund and authorizes the necessary budget transfer within the stormwater fund.

Section 2: That the City Manager, or designee, is hereby authorized to execute any necessary related documents and budget transfers/adjustments, upon consent of the City Attorney.

Section: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
