A RESOLUTION OF THE CITY COMMISSION OF THE OF KEY WEST, FLORIDA APPOINTING AN INDIVIDUAL TO FILL THE DISTRCT VACATED COMMISSION SEAT BY FORMER CITY COMMISSIONER MARY LOU HOOVER, PURSUANT TO SECTION 2-31 OF THE CODE OF ORDINANCES OF THE CITY OF KEY WEST, FLORIDA; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, a permanent vacancy occurred in the office of City Commissioner for District V on November 19, 2025; and

WHEREAS, Section 2-31(b) of the Code of Ordinances requires the City Commission, "... within fifteen (15) days of the occurrence of a permanent vacancy, to appoint an eligible person to serve until an election is held or until the end of the term."; and

WHEREAS, Section 2-31(b) further requires the City Commission to establish, by resolution, a procedure for the nomination and selection of the person to be appointed; and

WHEREAS, the City Commission in Resolution No. 95-517 established general rules of procedure, as well as rules of procedure for nomination and selection; and

WHEREAS, on November 24, 2025, the City Commission held a duly noticed special meeting setting forth the procedure for the December 2, 2025 City Commission meeting, including an application period;

WHEREAS, at its regularly scheduled meeting on December 2, 2025, the City Commission conducted nominations and voting to appoint a qualified individual to fill the District V seat;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the City Commission hereby appoints

to fill the District V Commission seat for the unexpired portion of the term of former Commissioner Mary Lou Hoover.

Section 2: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
