

RESOLUTION NO. _____

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA APPOINTING AN INDIVIDUAL TO FILL THE DISTRICT V CITY COMMISSION SEAT VACATED BY FORMER CITY COMMISSIONER MARY LOU HOOVER, PURSUANT TO SECTION 2-31 OF THE CODE OF ORDINANCES OF THE CITY OF KEY WEST, FLORIDA; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, a permanent vacancy occurred in the office of City Commissioner for District V on November 19, 2025; and

WHEREAS, Section 2-31(b) of the Code of Ordinances requires the City Commission, "... within fifteen (15) days of the occurrence of a permanent vacancy, to appoint an eligible person to serve until an election is held or until the end of the term."; and

WHEREAS, Section 2-31(b) further requires the City Commission to establish, by resolution, a procedure for the nomination and selection of the person to be appointed; and

WHEREAS, the City Commission in Resolution No. 95-517 established general rules of procedure, as well as rules of procedure for nomination and selection; and

WHEREAS, on November 24, 2025, the City Commission held a duly noticed special meeting setting forth the procedure for the December 2, 2025 City Commission meeting, including an application period;

WHEREAS, at its regularly scheduled meeting on December 2, 2025, the City Commission conducted nominations and voting to appoint a qualified individual to fill the District V seat;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the City Commission hereby appoints _____ to fill the District V Commission seat for the unexpired portion of the term of former Commissioner Mary Lou Hoover.

Section 2: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
