A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING L.E.A.D. INC. TO CONDUCT A "LEAD FEST CIRCUS KEY WEST" AT THE TRUMAN WATERFRONT PARK GRAVEL LOT ACROSS FROM THE AMPHITHEATER ON WEDNESDAY, FEBRUARY 24, 2027, THROUGH FRIDAY, FEBRUARY 26, 2027, FROM 4:00 P.M. TO 10:00 P.M. AND SATURDAY, FEBRUARY 27, 2027, AND SUNDAY, FEBRUARY 28, 2027, FROM 12:00 P.M. TO 10:00 P.M. (SETUP BEGINNING ON MONDAY, FEBRUARY 22, 2027); PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, L.E.A.D. Inc. has applied to the City for a Special Event Permit for a "LEAD Fest Circus Key West" at the Key West Truman Waterfront Park gravel lot across from the Amphitheater, on Wednesday, February 24, 2027, through Friday, February 26, 2027, from 4:00 p.m. to 10:00 p.m. and Saturday, February 27, 2027, and Sunday, February 28, 2027, from 12:00 p.m. to 10:00 p.m. Setup will begin on Monday, February 22, 2027.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST FLORIDA.

SECTION 1. That in Resolution 19-174, the City Commission directed the City Manager to "develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the provision of goods or services, unless such use is otherwise preempted by law."

SECTION 2. That vendor/lessee/licensee/contractor acknowledges the City's concern about the negative environmental impact of using disposable polystyrene products, which are neither readily recyclable nor biodegradable. Vendor/Lessee/licensee/contractor therefore commits to refrain from the use of polystyrene/plastic straws, bags, plastic utensils and "To go" packages for food or products sold on any property leased from the City.

SECTION 3. That L.E.A.D. Inc. is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place at the time and place herein described; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the City is executed; and that the organization meets the terms and conditions set forth by the City Manager.

SECTION 4. That L.E.A.D. Inc. is hereby granted permission for the use of the Truman Waterfront Park gravel lot across from the Amphitheater.

SECTION 5. That L.E.A.D. Inc. will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.

SECTION 8. That L.E.A.D. Inc. acknowledges that they are responsible for payment to the Key West Police Department, the Key

West Fire Department and Community Services.

SECTION 9. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and the Clerk of the Commission.
