An Ordinance of the City of Key West, Florida, adopting an Ad Valorem Tax General Municipal Millage Rate for FY 2019-2020; Providing for severability; Providing for repeal of inconsistent provisions; Providing for an effective date.

A motion was made by Commissioner Kaufman, seconded by Commissioner Hoover, that the Ordinance be Passed to Second Reading with the adopted ad valorem tax general municipal millage rate for FY 2019-2020 is set at 2.1535 mills (2.1535 per thousand dollars of assessed property value). The 2019-2020 final adopted millage rate is equal to 3.50 percent more that the rolled back rate of 2.0807 mills (\$2.0807 per thousand dollars of assessed property value). - 3 An Ordinance of the City of Key West, Florida, Amending Chapter 2 of the Code of Ordinances, entitled “Administration” to adjust the purchasing process for supplies and services of minimum dollar values necessary for the effective operation of City Government by Amending Article V. - Committees, Boards and Commissions, Division 10 entitled “Key West Bight Management District Board”, Section 2-553 to adjust the proposed timeframe for the Key West Bight Management District to adopt a proposed budget, and Amending Section 2-554 to adjust the requirement for City Commission approval of expenditures and budget transfers within Key West Bight to \$50,000.00; by Amending Article VII. - Financial Matters, Division 2 entitled “Budget” by amending Sections 2-736 through 2-739 to adjust the requirement for City Commission approval of expenditures and budget transfers to \$50,000.00; by amending Article VII “Financial Matters, Division 3 entitled “Personal property purchasing and procurement” Sections 2-766 through 2-845 to adjust the requirement for City Commission approval of expenditures to \$50,000.00 and by adding Section 2-800 to provide for quarterly reporting of purchases from \$20,000.01 to \$50,000.00; providing for severability; providing for repeal of inconsistent provisions; providing for an effective date.
