-- Francisco Efrain Bedregal Arrest Narrative:

On 06/01/2024 at approximately 1535 hours, I was dispatched to 626 Duval Street, in regard to a disturbance with a party trying to fight others in the restaurant.

Upon my arrival, a subject later identified as Francisco E. Bedregal, a male, born on 11/30/1991 was behind the bar holding onto the shirt collar of an employee of the business. Ofc. Howell and I separated Bedregal and instructed him to sit down on a bar stool at the rear of the bar with his wife Briana M Gaydos, a female born on 06/02/1992. Bedregal continued to yell profanities at employees, officers, and his wife. At this time it was determined that due to his aggressive nature and combative behavior to placed him into handcuffs for disorderly conduct so that I could continue my investigation as to what had transpired prior to my arrival. Upon trying to place Bedregal into handcuffs he began to actively resist arrest by pulling his hands away and attempting to push away by placing his hand in my chest and pushing off. Due to Bedregal's increasing levels of resistance and failure to comply with legal, lawful orders, Bedregal was moved to the ground in a controlled manner. Bedregal continued to resist by biting me on my left hand and pulling his hands away. Bedregal attempted to hold his hands under himself to prevent handcuffing. When he was unable to take control of his hands from me and Ofc. Howell, Bedregal began to push off each of us by grabbing for my throat and Ofc. Howell's vest. Due to the increasing levels of resistance and failure to comply with legal, lawful orders, a mix of joint manipulation and pain compliance was used to subdue and secure Bedregal placing him into handcuffs.

Once into handcuffs, Bedregal continued to resist by refusing to walk on his own to the patrol vehicle. Due to the increasing levels of resistance and failure to comply with legal, lawful orders, joint manipulation was used to gain compliance from Bedregal walking to the patrol vehicle. Once in the vehicle, Bedregal began to kick the window and scream obscenities toward Ofc. Howell and me, which he continued while being transported to the Monroe County Detention Center.

Ofc. Stevens interviewed the victims and witnesses at 626 Duval Street. Ofc. Stevens later explained that at some point Bedregal began attempting to start physical altercations within the business. Ofc. Stevens explained that Bedregal became frustrated with employees of the business because they would not engage in a physical altercation and began threatening his harm his wife. Ofc. Steven stated that Bedregal lost interest in fighting with his wife and then entered the bar area and eventually the kitchen of the business. Bedregal began screaming obscenities and grabbing an employee's, Albert Yegamberdiev's, shirt collar in an attempt to instigate a physical altercation. Other employees intervened and attempted to remove Bedregal from the kitchen and bar area. At this point, Ofc. Howell and I arrived on the scene. Reference Ofc. Steven's supplemental report for further information.

Bedregal was not injured in the arrest, and refused medical attention on scene

Based on the facts and evidence, I believe there is probable cause that on 06/01/2024, Francisco E. Bedregal did knowingly and intentionally violate F.S.S. 784.07-2B Battery on LEO, by actually and intentionally biting my hand while struggling to pull his hands from me as Ofc. Howell and I were handcuffing Bedregal, while I was engaged in my legal, lawful duties as a uniformed law enforcement officer.

Based on the facts and evidence, I believe there is probable cause that on 06/01/2024, Francisco E. Bedregal did knowingly and intentionally violate F.S.S. 843.01 Resisting with Violence, by actually and purposely threatening to and attempting to initiate a physical altercation with Ofc. Howell and me, while pushing Ofc. Howell and me as well as grabbing my throat as we attempted to place Bedregal in handcuffs, while we were engaged in our legal, lawful

duties as uniformed law enforcement officers.

Based on the facts and evidence, I believe there is probable cause that on 06/01/2024, Francisco E. Bedregal did knowingly and intentionally violate F.S.S. 784.03 Battery, by actually and purposefully grabbing Albert Yegamberdiev by his shirt collar, touching him against his will, and attempting to cause Yegamberdiev bodily harm.

Based on the facts and evidence, I believe there is probable cause that on 06/01/2024, Francisco E. Bedregal did knowingly and intentionally violate F.S.S. 509.143 Disorderly Conduct on The Premises of An Establishment, by actually and purposefully disturbing the peace, committing acts that outraged the sense of public decency by causing a physical altercation with employees of said premises while refusing to leave a licensed establishment.

Based on the facts and evidence, I believe there is probable cause that on 06/01/2024, Francisco E. Bedregal did knowingly and intentionally F.S.S. 810.08 Trespass in Structure or Conveyance, by actually and intentionally remaining on the premises and refusing to leave the property, after being warned several times verbally by employees as well as multiple verbal warnings from uniformed law enforcement officers.

On June 1, 2024, I was dispatched to "Pho King Awesome", 626 Duval St, Key West, Florida, in reference to a physical fight. Dispatch advised that an Hispanic male had entered the restaurant and was actively fighting the chef, whom the chef did not know. Ofcs Howell and Christina arrived prior to me and, upon my arrival, they were talking to the suspect, later identified as Francisco BEDREGAL. BEDREGAL was shouting profanities and there was a white female, apparently with him, trying to calm him down.

I spoke to the caller, later identified as Moldir TAJIGULOVA a server at the restaurant. She told me that BEDREGAL and the female had come into the restaurant and they sat at the bar and had several drinks. BEDREGAL told TAJIGULOVA that he is from Peru and he wanted to fight someone. TAJIGULOVA told him that he cannot fight in there and he pointed to his female companion and said that he would fight her. TAJIGULOVA reiterated that he cannot fight in there and at some point, BEDREGAL went to the bathroom. When he emerged from the bathroom BEDREGAL went behind the counter and walked into the kitchen. Then using both hands, he grabbed the chef (later identified as Albert EGAMBERDIEV) by the front of his shirt and said that he wanted to fight him. The other chef, Elburus EGAMBERDIEV, intervened and pulled BEDREGAL away from Albert. TAJIGULOVA said that she did not see BEDREGAL grab Albert, but Elburus did.

I then went to consult with Ofcs Howell and Christina and they had elected to arrest BEDREGAL, who was still shouting and using loud profanity. As they tried to arrest him, BEDREGAL resisted and all three went to the ground. Both officers' body worn cameras (BWC) became detached from their uniform and I retrieved them, placing them on a nearby table.

Ofcs Howell and Christina struggled to handcuff BEDREGAL and he continued to resist their efforts by holding his hands in front of him, tensing and squirming. I withdrew my Taser and told BEDREGAL to stop resisting or he would be tazed. Ofcs Howell and Christina were finally able to gain control of BEDREGAL and place him in handcuffs. As they led him to their marked police car outside, BEDREGAL continued to shout. After he was placed and seatbelted into the backseat, I returned their BWC's to them and I summoned Sgt Duponty to the scene.

I then gathered the witnesses' information and Albert EGAMBERDIEV said that he wished to pursue charges. Outside, I apprised Ofcs Howell and Christina of what I had learned. BEDREGAL started to kick the door of Ofc Howell's police car so hard that it was visibly buckling. Ofc Howell opened the door and told him to stop. After he closed the door, BEDREGAL started kicking the door again with obvious force. Sgt Duponty spoke with BEDREGAL and advised Ofc Howell to transport him to jail. BEDREGAL continued to kick at the car door and I offered to follow Ofcs Howell and Christina to the jail in the event that they needed to pull over to apply a hobble restraint to BEDREGAL. I gave Ofc Abreu a victim's rights brochure and directed her to issue it to EGAMBERDIEV.

At MCDC, BEDREGAL was brought to intake and he was crying and shouting. Once detention deputies had accepted custody of BEDREGAL I left.

Ofc Mitchell then sent me two video clips that he had received from TAJIGULOVA that showed BEDREGAL holding Albert by the front of his shirt with both hands, pushing him against a wall as Elburus tried to intervene. BEDREGAL appeared to have his entire body pressed against Albert as he pushed him forcefully against the wall. Elburus is also visible trying to intervene without success. Albert had a fearful look on his face and in one video, BEDREGAL can be heard saying, "fuck you and your family". He then turns to the camera and says, "go ahead, call the cops".

I have since uploaded footage captured by my BWC, in addition to the footage of the battery, to the evidence server.
