VISUALIZE ENTERTAINMENT, INC. DBA KEY WEST OUTDOOR MOVIES AT  
TRUMAN WATERFRONT PARK  
- REVOCABLE LICENSE

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE CITY OF KEY WEST TO ENTER INTO A REVOCABLE LICENSE AGREEMENT FOR NONPERMANENT USE OF CITY PROPERTY WITH VISUALIZE ENTERTAINMENT, INC. TO ALLOW THE OPERATION OF KEY WEST OUTDOOR MOVIES WITH VENDORS TWO TIMES MONTHLY FOR AN EIGHT-MONTH PERIOD, UPON ADDITIONAL TERMS AND CONDITIONS CONTAINED IN THE AGREEMENT (OCTOBER 2019 THROUGH MAY 2020); PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Section 2-939 of the Code of Ordinances of the City of Key West, Florida allows the City to grant a revocable license for a nonpermanent use of City property; and

WHEREAS, the City Commission finds that regularly scheduled outdoor movies with related vendors provides local entertainment and non-profit fund-raising opportunities, and thereby provides a benefit to residents and visitors;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the City Manager is hereby authorized to execute the attached Revocable License Agreement for Use of City Property (the "Agreement") between the City and Visualize

Entertainment, Inc. for the use of a designated area of Truman Waterfront Park for Key West Outdoor Movies, twice a month, upon specific terms and conditions set forth in the Agreement (October 2019 through May 2020).

Section 2: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
