A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING A LOCAL AGENCY PROGRAM (LAP) AGREEMENT BETWEEN THE CITY OF KEY WEST AND THE FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) IN THE AMOUNT OF \$250,000.00 FOR A BICYCLE AND PEDESTRIAN MASTER PLAN (FM# 438687-1); AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS; AUTHORIZING A BUDGET AMENDMENT; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, for over a decade, Key West has ranked 1<sup>st</sup> out of 97 Florida cities in bicycle injuries and fatalities, and in the top 10% of Florida cities for pedestrian injuries and fatalities; and

WHEREAS, in 2015 the City applied for and has been awarded funding through FDOT's Transportation Alternatives Program (TAP) for the development of a bicycle and pedestrian master plan to develop infrastructure-related projects and systems to provide safe routes for non-drivers; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the City Manager is authorized to execute the attached Local Agency Program (LAP) grant agreement with the State of Florida Department of Transportation (FDOT) for a Bicycle and Pedestrian Master Plan (FM 438687-1) in the amount of \$250,000.00.

Section 2: That the City Manager is authorized to execute necessary documents upon consent of the City Attorney.

Section 3: That amendments to the budget reflecting FDOT LAP revenue, in the amount of \$250,000.00 for the bicycle and pedestrian master plan to account 001-0000-331-9000, and to project expense account 001-1501-515-3100 in the amount of \$250,000.00 are hereby authorized (100% reimbursement to City).

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission. Passed and adopted by the City Commission at a meeting held this \_\_\_\_\_ day of \_\_\_\_\_, 2016.
