# TUESDAY, JUNE 1, 2010

A regular meeting of the City Commission of the City of Key West, Florida was held in Commission Chambers, Old City Hall, on Tuesday, June 1, 2010.

Mayor Craig Cates called the meeting to order at 6:00 p.m.

Answering roll call were Commissioners Barry Gibson, Teri Johnston, Clayton Lopez, Mark Rossi, Billy Wardlow, Jimmy Weekley and Mayor Craig Cates.

Also present were City Manager Jim Scholl, Assistant City Manager David Fernandez, Assistant City Manager Mark Finigan, City Attorney Shawn Smith, City Planner Amy Kimball-Murley, Fire Chief David Fraga, Division Chief/EMG Management & Training Craig Marston, General Services Director Gary Bowman, Utilities Manager Jay Gewin, Parking Manager John Wilkins, Senior Property Manager Marilyn Wilbarger, Deputy Clerk Angela Budde, Senior Deputy City Clerk Sue Harrison and City Clerk Cheri Smith.

Pastor Timothy Jemly of Impact Community Church gave the invocation.

The pledge of allegiance to the flag of the United States of America was given by all present.

# CHANGES TO THE AGENDA

City Manager Jim Scholl requested Resolution 4 be removed from the consent agenda. Without opposition, the agenda was accepted as changed.

#### PRESENTATIONS:

(a) City Attorney's Report

City Attorney Smith had no report for the Commission.

(b) City Manager's Report

City Manager Scholl stated Mr. Andrew Van Chow from British Petroleum (BP) would update the Commission regarding the Deepwater Horizon oil spill. Mr. Van Chow stated there were over 1,600 vessels mobilized participating in the recovery efforts and 1.9 million feet of containment boom deployed and an additional 1.8 million feet of absorbent booms. He stated they had opened a claims office in Marathon and would be opening a claims office in Key West by the end of the week. He stated there were two relief wells being drilled and the anticipated completion date would be some time in August.

Commissioner Weekley asked about money from BP to the local Tourist Development Counsel for advertising for the Florida Keys and Key West. Mr. Van Chow responded that Monroe County Commissioner Di Gennaro has been appointed by the Governor to represent Key West and Monroe County with regard to the \$25,000,000.00.

Mr. Scholl stated that Trish Monroe had passed away last week after a long illness. She had worked in the building department for 12 years.

Mr. Scholl stated the Navy Base will be commemorating the Battle of Midway on Thursday at the Military Memorial at Mallory Square at 8:00 a.m.

Commissioner Johnston asked Mr. Scholl about the Wisteria Island proposal and what the City's responsibility was at this point. Mr. Scholl stated the County was at the beginning of a very lengthy, complicated process. His understanding was that the County was proceeding with some complex changes in order to enable any type of potential development to occur on Wisteria Island and he did not

believe there would be a formal proposal for the City to take a vote. He asked the City Planner, Amy Kimball-Murley to address the issue.

Ms. Amy Kimball-Murley, Planning Director, described the process the County was following regarding the Wisteria Island issue. Staff reviewed the applications and she stated the information provided was superficial at this stage. She stated this was a County Land Use Modification amendment. The whole process could take several months. The City was at a technical impact review stage for this project.

Commissioner Gibson asked for updates on the Port and Transit Director. Mr. Scholl stated there were nineteen applicants considered and the selection was narrowed down to three that met the requirements. He stated two of the three were interviewed, as one was not available, and the applicant selected was due to start near the end of July.

Commissioner Rossi asked about the Waterfront Market. Ms. Wilbarger stated according to the settlement agreement they would vacate the property before June 30, 2010. Notice will be made and proposals will be accepted to lease the space.

#### WHO MUST FILE FORM 8B

This form is for use by any person serving at the county, city, or other local level of government on an appointed or elected board, council, commission, authority, or committee. It applies equally to members of advisory and non-advisory bodies who are presented with a voting conflict of interest under Section 112.3143, Florida Statutes.

Your responsibilities under the law when faced with voting on a measure in which you have a conflict of interest will vary greatly depending on whether you hold an elective or appointive position. For this reason, please pay close attention to the instructions on this form before completing the reverse side and filing the form.

# INSTRUCTIONS FOR COMPLIANCE WITH SECTION 112.3143, FLORIDA STATUTES

A person holding elective or appointive county, municipal, or other local public office MUST ABSTAIN from voting on a measure which inures to his or her special private gain or loss. Each elected or appointed local officer also is prohibited from knowingly voting on a measure which inures to the special gain or loss of a principal (other than a government agency) by whom he or she is retained (including the parent organization or subsidiary of a corporate principal by which he or she is retained); to the special private gain or loss of a relative; or to the special private gain or loss of a business associate. Commissioners of community redevelopment agencies under Sec. 163.356 or 163.357, F.S., and officers of independent special tax districts elected on a one-acre, one-vote basis are not prohibited from voting in that capacity.

For purposes of this law, a "relative" includes only the officer's father, mother, son, daughter, husband, wife, brother, sister, father-in-law, mother-in-law, son-in-law, and daughter-in-law. A "business associate" means any person or entity engaged in or carrying on a business enterprise with the officer as a partner, joint venturer, coowner of property, or corporate shareholder (where the shares of the corporation are not listed on any national or regional stock exchange).

## **ELECTED OFFICERS:**

In addition to abstaining from voting in the situations described above, you must disclose the conflict:

PRIOR TO THE VOTE BEING TAKEN by publicly stating to the assembly the nature of your interest in the measure on which you are abstaining from voting; and

WITHIN 15 DAYS AFTER THE VOTE OCCURS by completing and filing this form with the person responsible for recording the minutes of the meeting, who should incorporate the form in the minutes.

# APPOINTED OFFICERS:

You must abstain from voting and disclose the conflict in the situations described above and in the manner described for elected officers. In order to participate in these matters, you must disclose the nature of the conflict before making any attempt to influence the decision, whether orally or in writing and whether made by you or at your direction.

IF YOU INTEND TO MAKE ANY ATTEMPT TO INFLUENCE THE DECISION PRIOR TO THE MEETING AT WHICH THE VOTE WILL BE TAKEN:

- You must complete and file this form (before making any attempt to influence the decision) with the person responsible for
  recording the minutes of the meeting, who will incorporate the form in the minutes.
- A copy of the form must be provided immediately to the other members of the agency.
- . The form must be read publicly at the next meeting after the form is filed.

# IF YOU MAKE NO ATTEMPT TO INFLUENCE THE DECISION EXCEPT BY DISCUSSION AT THE MEETING:

- · You must disclose orally the nature of your conflict in the measure before participating.
- You must complete the form and file it within 15 days after the vote occurs with the person responsible for recording the minutes of the meeting, who must incorporate the form in the minutes. A copy of the form must be provided immediately to the other members of the agency, and the form must be read publicly at the next meeting after the form is filed.
