A RESOLUTION OF THE CITY COMMISSION OF THE OF KEY WEST, FLORIDA, APPROVING A PURCHASE FROM TEN-8 FIRE & SAFETY, LLC IN AN NOT TO EXCEED \$939,450.00 OPTIONAL PRE-PAYMENT DISCOUNT) INCLUDING THE PURCHASE OF ONE 2026 PIERCE IMPEL PUMPER APPARATUS INCLUDING ALL NECESSARY OPTIONS AND EQUIPMENT PURSUANT TO GOVERNMENT CONTRACT, SECTION 2-797(3) OF THE CODE OF ORDINANCES; AUTHORIZING NECESSARY BUDGET TRANSFERS OR ADJUSTMENTS: AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE NECESSARY DOCUMENTS UPON ADVICE AND CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Fire Department administrative staff has recommended the purchase of a fire pumper apparatus from Ten-8 Fire & Safety, LLC, under the Florida Sheriff's Association (FSA) Bid No. FSA 23-VEF 17.0 for fire rescue vehicles and other equipment, pursuant to section 2-797(3) of the Code of Ordinances; and

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That a purchase from Ten-8 Fire & Safety, LLC in an amount not to exceed \$939,450 (including optional pre-pay discount), of one 2026 Pierce Impel Pumper Apparatus with necessary

options and equipment, is hereby approved, pursuant to Section 2-797(3) of the code of ordinances.

Section 2: That funds in the amount of \$820,000.00 are budgeted for this acquisition and allocated in FY 23/24 Fire Department Infrastructure Fund under Budget account 101-2201-522-6400. The remaining funds necessary will be covered through a re-allocation of existing funds budgeted in the Fire Department Infrastructure Surtax Fund, account number 101-2201-522-6400.

Section 3: That the City Manager or designee is authorized to execute necessary documents related to this purchase upon advice and consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
