

RESOLUTION NO.

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING A WAIVER OF FORMAL BIDDING PROCEDURES, AND AUTHORIZING PURSUANT TO SECTION 2-797(3), 2-797(4)(b) AND 2-798(b) OF THE CODE OF ORDINANCES, AS FUNDED THROUGH FDOT GRANT ARN97, THE FOLLOWING PURCHASES: ONE (1) DIESEL PARTICULATE FILTER CLEANER IN AN AMOUNT NOT TO EXCEED \$30,000.00 FROM PREMIUM AUTO PARTS OF KEY WEST, LLC; ONE YALE MODEL GP050VX DIESEL FORKLIFT IN AN AMOUNT NOT TO EXCEED \$32,855.00 FROM MACKINNON EQUIPMENT SERVICES; ONE (1) 2016 CHEVROLET 3500 DIESEL SERVICE TRUCK WITH KNAPEIDE BODY AND LIFT GATE IN AN AMOUNT NOT TO EXCEED \$76,984.43 FROM NILES SALES AND SERVICE; AUTHORIZING ANY NECESSARY BUDGET ADJUSTMENTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 15-318 the City Commission accepted an allocated grant funding authorization in the amount of \$1,173,661.00 from the Florida Department of Transportation for the purchase of replacement buses and necessary equipment for the new transit facility; and

WHEREAS, City staff obtained three price quotes for a diesel particulate filter cleaner, and for a diesel forklift, and reasonably believes that a formal invitation to bid would not result in a more favorable price for either item, and recommends authorizing these purchases pursuant to section 2-797(4), best interests of the City; and

WHEREAS, a local vendor, Niles Sales & Service, Inc., matched the pricing of the 2015 Florida Sheriff's Association Contract for motor vehicles for the 2016 Chevrolet 3500 Diesel truck plus non-identified contract accessory options, pursuant to Sec. 2-798; and

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of one diesel particulate filter cleaner from Premium Auto Parts of Key West, LLC in an amount not to exceed \$30,000.00 is hereby authorized pursuant to section 2-797(4) (b) of the Code of Ordinances.

Section 2: That the purchase of one Yale Model GP050VX Diesel Forklift from MacKinnon Equipment Services in an amount not to exceed \$32,855.00 is hereby authorized pursuant to section 2-797(4) (b) of the Code of Ordinances.

Section 3: That the purchase of one 2016 Chevrolet 3500 Diesel Service Truck with Knapheide Body and Lift Gate from Niles Sales and Service of Key West in an amount not to exceed \$76,984.43 is hereby authorized pursuant to section 2-798 of the Code of Ordinances.

Section 4: That these purchase are budgeted for FY 15-16, through funds allocated in FDOT Grant ARN97, as approved in Resolution 15-318.

Section 5: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
