Dear Shawn:

Please consider this letter as a summary of how I might be able to help the City of Key West in a transitional role over the next year or so. I've enclosed a description of my experience in local government, quasi-government, bar and private practice. I don't know of anyone who has served longer as city attorney of a large city in Florida than I have, nor any public or private practitioner who has handled as many matters for government as I have. For 18 years, I've managed the legal matters for the City of Orlando, including bonds and public finance; negotiating our venues deals and TDT funds for Kia Center, Camping World Stadium and our performing art center; labor matters, including human resources, public safety discipline matters and employment law; land use zoning and permitting, risk management/litigation, and public works. I have also mentored and counseled many young lawyers, including our lawyers at the city, and the lawyers who have worked for me for many years, beginning as summer clerks and some now my law partners. In addition to managing legal affairs for the city, my partner Jeff Aaron and I handle legal matters for our aviation authority, at both the Orlando International Airport and our local executive airport. Our airport work includes many of the same subject matters as those we handle for the city, particularly including land use, zoning and permitting, litigation and regulatory matters (FAA-based, in the case of the airport work we do). Our lawyers at DownsAaron also handle a wide array of litigation and business dispute matters in the private sector.

I would be honored to have the opportunity to help the City of Key West. The work I do for local governments is the work I am most proud of and I am willing to extend to Key West a discounted rate of \$495.00/hour (my standard rate is \$825.00/hour). I propose to provide legal services for as long as the City desires, with my engagement agreement terminable at any time. I will bill monthly and that bill will include reasonable travel costs, although I anticipate most of my work can be done remotely.
