A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING LITERACY VOLUNTEERS OF AMERICA-MONROE COUNTY, INC. TO CONDUCT IT'S ANNUAL CARIBBEAN STREET FAIR ON SATURDAY, JULY 20, 2024, FROM 10:00 A.M. TO 9:00 P.M. (SET UP 8:00 A.M.); PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE CLOSURE OF THE 200, 300 & 400 BLOCKS OF DUVAL STREET BETWEEN THE HOURS OF 10:00 A.M TO 9:00 PM; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Literacy Volunteers of America-Monroe County, Inc. wishes to conduct their annual Caribbean Street Fair; and

**NOW, THEREFORE, BE IT RESOLVED** by the City Commission of the City of Key West, Florida.

**SECTION 1.** That in Resolution 19-174, the City Commission directed the city manager to "develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the local government for the provision of good or services, unless such use is otherwise preempted by law."

SECTION 2. "That the vendor/lessee/licensee acknowledges the City's concern about the negative environmental impact of using disposable polystyrene products, which are neither readily recyclable nor biodegradable. Vendor/Lessee/licensee/contractor therefore commits to refrain from the use of polystyrene/plastic straws, bags, plastic utensils and "To go" packages for food or products sold on any property leased from the City."

**SECTION 3.** That Literacy Volunteers of America – Monroe County, Inc. is hereby

granted permission to conduct the Caribbean Street Fair on the day and during the hours stated above, PROVIDED that all trash is collected and contained; that a guarantee indemnifying the city is executed; that the organization meets the terms and conditions set forth by the City Manager.

**SECTION 4.** That Literacy Volunteers of America-Monroe County, Inc. is hereby granted permission for the closure of 200, 300 & 400 blocks of Duval Street on the date and during the hours stated above.

**SECTION 5.** That Literacy Volunteers of American-Monroe County, Inc. will adhere to the recycling plan of the City of Key West, that one (1) recycling container for everyone (1) trash barrels will be used and that they will be placed side by side.

**SECTION 6.** That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
