**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING SUNSET CITY LESSEE, LLC DBA THE SOUTHERNMOST BEACH CAFE THE USE OF CITY PROPERTY AT 1405 DUVAL STREET FOR A CONCERT BENEFITING THE MAY SANDS MONTESSORI SCHOOL ON TUESDAY, MAY 7, 2019 FROM 7:00 P.M. TO 10:00 P.M.; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE BARRICADED AREA; PROVIDING FOR AN EFFECITVE DATE**

**WHEREAS**, Sunset City Lessee, LLC DBA Southernmost Beach Cafe wishes to use the Southernmost Beach Cafe Site between the hours of 7:00 p.m. to 10:00 p.m. on Tuesday, May 7, 2019 for a concert; and

**WHEREAS**, this event shall take place on the grounds of the Southernmost Beach Cafe between the hours of 7:00 p.m.to 10:00 p.m; and

**NOW THEREFORE, BE IT RESOLVED**, by the City Commission of the City of Key West, Florida;

**SECTION 1.** That Sunset City Lessee, LLC DBA the Southernmost Beach Cafe is hereby granted permission for the use of the Southernmost Beach Cafe site on the date and during the hours stated above; PROVIDED all trash is adequately collected and contained; guarantees indemnifying the City is executed; and provided the organizations meet the terms and conditions set forth by the City Manager.

**SECTION 2.** That pursuant to Section 18-86 of the Key West Code of Ordinances, permission is granted to allow the sale and consumption of alcoholic beverages within the enclosed area.

**SECTION 3.** That the Southernmost Beach Cafe will adhere to the recycling plan of the City of Key West.

**SECTION 4.** That Sunset City Lessee, LLC DBA Southernmost Beach Café must post the required notice regarding prohibition of purchase and sale of alcoholic beverages to persons under 21 years of age.

**SECTION 5.** That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
