TO 12:00 MIDNIGHT; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE CLOSURE OF THE 400 BLOCK OF GREENE STREET BETWEEN DUVAL STREET AND TELEGRAPH LANE FROM 5:00 P.M. TO 12:00 MIDNIGHT; GRANTING A SPECIAL EVENT PERMIT PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES FROM 5:00 P.M. TO 12:00 MIDNIGHT; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE BARRICADED AREA; PROVIDING FOR AN EFFECTIVE DATE

SECTION 2. That the other bar participating in the liquor extension is Craft Culture Key West, LLC.

SECTION 3. That 425 Tacos, LLC dba Amigos Tortilla Bar is hereby granted permission for the closure of the 400 block of Greene Street between Duval and Telegraph Lane on the date and during the hours stated above.

SECTION 4. That 425 Tacos, LLC dba Amigos Tortilla Bar is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take

place and time herein described.
