

### ACTION STATEMENT

Resolution rejecting bids for ITB #17-004 – Dockmaster / Transient Restroom Building – City Marina at Garrison Bight.

### BACKGROUND

City Marina at Garrison Bight requires infrastructure improvements to its transient facilities. The City has received a Boating Infrastructure Grant (BIG) in the amount of \$500,000.00 (res. 11-241) for these improvements. The facilities will include new restroom facilities and electrical wiring to its transient docks.

The transient bath house which includes toilet facilities and showers has exceeded its life expectancy. Although renovated in the past, the facility is substandard and detracts from our transient guests staying at the marina. The dockmaster offices are located in a trailer directly adjacent to the transient bath house. The space is small with no public restrooms and lacks adequate storage and work space. A combined use facility will provide a modern transient facility with toilet facilities, showers, laundry, dockmaster offices, storage, work space and public restrooms.

City Marina has a budget of \$1,300,000 which includes grant funding.

### PURPOSE & JUSTIFICATION

ITB #17-004 was advertised February 2017 for a new dockmaster/ transient restroom facility. Bids were received from three contractors on March 15, 2017 as follows:

Section 3: In the event the grant is awarded to the City, the final grant contract will be brought before the City Commission for approval.





### Action statement:

This resolution will authorize the City Manager to apply for and administer the grant submitted to the Florida Fish and Wildlife Conservation Commission under the Boating Infrastructure Grant program on behalf of the City Marina at Garrison Bight for the purposes of constructing a new transient boater facility.

This resolution will also state that the City Commission is willing to enter into a 20-year agreement for the maintenance and operation of the facility. In the event that the grant is awarded it will come before the City Commission for final approval.

### Background:

City Marina at Garrison Bight requires infrastructure improvements to transient facilities which are eligible under the Boating Infrastructure Grant program. These improvements include new restroom facilities and electrical wiring to the transient docks.

### Scope of Services:

The transient bath house which includes toilet facilities and showers has exceeded its life expectancy. Although renovated, the facility is substandard and detracts from our transient guests stay at the marina. The current bath house facility will be demolished and removed from the property. A brand new bath house facility including laundry amenities will be constructed for transient use.

Kingfish and Wahoo are the two floating docks at the marina that are available for transient boaters. The electric lines that feed the docks are original and have exceeded their life expectancy. The condition of the wiring has led to power outages to the docks and individual slips prompting emergency repairs and relocation of transient visitors.



Continued use of the existing wiring may create life safety issues as there appears to be stray current entering the water surrounding the docks coming from the existing wiring.

The new building will be designed LEED certified. The construction will use the most sustainable building practices available to comply with LEED, including: building with reusable materials, energy saving roofing and insulation, the highest efficiency rated HVAC available, water saving appliances and flushometers, and use of LED lighting. The items used will not only be chosen for efficiency but with lower maintenance costs in mind.

The expected results and benefits of the proposed project will provide transient visitor's to the City Marina a safe and comfortable visit during their stay in Key West. With the proposed improvements it is projected that the number of visitors will increase by 30%, getting back to 2007 occupancy levels, and will increase by 25% each year thereafter.

The grant funding will also allow the City Marina to maintain its affordable rates encouraging more transient boater visitor's to the City of Key West.

**The project timeline:**

60 Days: Design and Engineering

40 Days: Bidding

30 Days: Commission Approval

30 Days: Mobilization

14 Days: Demolition

150 Days: Construction (60 day construction for electrical wiring of transient docks)

**Financial:**

The estimated cost of proposed improvements is \$900,000. The grant request submitted is for \$500,000 and City Marina is matching \$400,000 or 40% of the grant. This is a reimbursable grant, so the City will pay for improvements upfront and be reimbursed by FWCC. City Marina has reserved funding for this project.

**Recommendation:**

Approve the resolution authorizing the City Manager to submit an application and if approved execute an agreement with the Fish and Wildlife Conservation Commission for infrastructure improvements of transient boater facilities at City Marina at Garrison Bight.

<p>City Marina at Garrison Bight is owned and operated by the City of Key West Florida. The marina has the capacity of up to 80 transient slips. The facility was built in the 1950s and the City has been renovating the marina's infrastructure for the past several years. Two major projects which still require modernization are the original transient bath house, and the electric lines running out to the transient docks that supply electricity to transient visitor's boats.</p> <p>The bath house has had several renovations over the years but the building has exceeded its life expectancy and needs to be replaced. The main power lines running out the transient docks also have outlived their life expectancy resulting in frequent power outages and stray current in the waters surrounding the docks. For the past several years the number of transient visitors to the marina has declined due in part to the marina's deteriorating infrastructure. City Marina has the most affordable transient dockage rates in the City of Key West. Grant funding is being requested to help make these major infrastructure improvements and still maintain the low transient dockage rates our customers enjoy. Additionally these improvements will vastly improve our customers experience while staying at the marina and will lead to additional transient boaters visiting the marina once word of improvements is spread throughout the boating world.</p>
