A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, CREATING THE LAZY WAY LANE PEDESTRIAN PROMENADE PILOT PROGRAM, A PEDESTRIAN CORRIDOR FROM 6:00 PM TO 4:00 AM EVERY DAY ON LAZY WAY BETWEEN WILLIAM STREET AND ELIZABETH STREET FOR A PERIOD OF ONE YEAR; AUTHORIZING 24-HOUR ACCESS FOR NON-MOTORIZED TRAFFIC, ADA-COMPLIANT MOBILITY DEVICES, AND FOR VEHICLES ESSENTIAL FOR MAINTENANCE, REPAIRS AND TIME-SENSITIVE COMMERCIAL ACTIVITIES RELATED TO PUBLIC AND PRIVATE PROPERTY ALONG LAZY WAY; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY NECESSARY DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, at its meeting of August [10], 2022, the Key West Bight Management District Board determined that it would be beneficial to create a pilot program to make Lazy Way a pedestrian promenade at night, with the intention of improving public safety; and

WHEREAS, the Commission acknowledges that the "pedestrian promenade" should not hinder tenants or the City from performing essential repairs, maintenance or commercial activities, and that it is reasonable to always allow non-motorized (bicycle, pedicab) and ADA mobility-related traffic in the area; and

WHEREAS, accordingly the City Commission accepts the recommendation of the Key West Bight Management Board, and herein shall establish the "Lazy Way Pedestrian Promenade Pilot Program."

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the City Commission for the City of Key West hereby establishes the Lazy Way Pedestrian Promenade Pilot Program, to operate from 6 pm to 4 am each day on Lazy Way between William Street and Elizabeth Street for a period of up to one-year.

Section 2: That non-motorized vehicles (bicycles, pedicabs), ADA-compliant mobility devices and all vehicles essential for maintenance, repair and time-sensitive commercial activities related to public and private property along Lazy Way shall be allowed as necessary during the pedestrian promenade hours.

Section 3: The City Manager is authorized to temporarily suspend or adjust the pedestrian promenade hours whenever necessary in the interests of public safety, or upon declaration of public emergency.

Section 4: That the Lazy Way Pedestrian Promenade Pilot Program shall commence on Friday, September \_\_\_\_\_, 2022 and shall sunset on Sunday September \_\_\_\_\_, 2023, unless otherwise cancelled or extended by Resolution of the City Commission.

Section 5: That the City Manager is authorized to execute any necessary documents/agreements to effectuate the terms of this Resolution upon the advice and consent of the City Attorney.

Section 6: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
