A regular meeting of the City Commission of the City of Key West, Florida was held in Commission Chambers, Old City Hall, on Tuesday, May 1, 2012.

Mayor Craig Cates called the meeting to order at 6:00 p.m.

City Attorney's Report

City Attorney Smith reported the Ordinance the Mayor has withdrawn from this agenda would be coming back before the Commission on the next agenda.

Mr. Scholl also reported on the repair of the pedestrian bridge that connects Mallory Square with the Westin. Commissioner Rossi asked about Admirals Cut in that area. Mr. Scholl stated that area would be dependent on the plan and development at the Truman Waterfront. He stated it was in the City's best interest to repair the pedestrian bridge.

Mr. Scholl reported on concrete repair at the Thompson Fish House at the Key West Bight.

Commissioner Yaniz requested of the City Manager that he be kept apprised of any major issues that affect the City particularly those that may be of a controversial nature so when he is contacted by constituents he can respond to their questions.
