(JW Waite 6/15/16) Today Code received a call from Inspector Ray who was out with a group of subjects performing work on a pool at 1217 Royal St. Inspector Ray advised the group the work had not been permitted and they needed to stop working in which they refused. On my arrival I met with Inspector Ray as well as a subject by the name of Dimitrus Bisen out of Georgia. Dimitrus advised the job was subcontracted to him by Charles Wicht of Crystal Clear Pools. The subjects on scene were day laborers and are not direct employees of Crystal Clear Pools. The group packed up their belongings and left the property shortly after. A Red Tag/Stop Work Order was placed on the front of the property citing the business with Sec. 14-37. I have not been able to make contact with Mr. Charles Wicht.


