Dear Commissioners:

On behalf of KOTO and it's 1000+ Facebook followers we respectfully request you conscientiously apply the HARC guidelines and accordingly reject the proposal for 415 Grinnell Street for the following reasons:

1) The guidelines declare an accessory garage highly visible from the public right-of-way inappropriate in the historic district. (Guidelines P40) 415 should not be allowed to locate a garage on the Grinnell Street elevation simply because it isn't an independent structure. It ruptures the streetscape.

2) The proposed house presents a solid first floor wall to the street as if a former porch had been encased with louvers. This would be expressly prohibited by the guideline stating the enclosing of a front porch is not appropriate (Guidelines P33). New construction should not be approved when it mimics that which is forbidden to historic structures.

3) The historic fabric of Old Town is characterized by open front porches and homes oriented toward the street whereas this design inappropriately turns it's back to the neighborhood. The guidelines require site orientation to be compatible with existing historic construction located near the site. (Guidelines P53) The interior orientation of the proposed structure fails this requirement 4) The house is too tall. If FEMA regulations are dictating the height of the first floor above grade then the developers will need to compromise on the 9' and 10' interior ceiling heights to bring the home into scale with its neighbors. (Guidelines P53)

5) Most roofing in the historic residential zones consists of sloped gables or hipped roofs. (Guidelines P53) Roofing forms used in new construction must be visually compatible with . . . the streetscape and neighborhood. (Guidelines P 26). The horizontal roof lines (used to accommodate a roof deck) are not compatible with the neighborhood. With respect to the roof deck - the only residential "roof decks" in Old Town are widow's walks. Roof lines should not be compromised to facilitate that which will intrude on the street and surrounding neighborhood.

In summary, the 415 Grinnell proposal should be rejected for the foregoing specific reasons and for failing the more general requirements of "compatibility" (Guidelines p.38a & 53), and that new construction "harmonize" with existing historical building stock (Guidelines p.38) and be "in keeping" with the historic character of Old Town (Guidelines p. 38a). While we recognize that "good contemporary design" is not excluded, emphasis should be placed on the second half of the same sentence encouraging only new <u>complementary</u> design.

Please deny this project as proposed.
