An application was received requesting the removal of **(1) Strangler Fig tree**. A site inspection was done on July 21, 2016 and documented the following:

Tree Species: Strangler Fig (*Ficus aurea*)

Location: 50% (too close to house, in utility lines, back yard tree-wrong tree, wrong place)

Species: 100% (on protected tree list)


Condition: 50% (fair)

Total Average Value = 66%

**Value x Diameter = 7.5 replacement caliper inches**

**Recommendation: Recommend approval of the removal of one (1) Strangler Fig tree at 1919 Harris Avenue to be replaced with 7.5 caliper inches of dicot or fruit trees from approved list, FL#1, to be planted on site.**






