**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING KEY WEST CULTURAL PRESERVATION SOCIETY, INC. TO CONDUCT A FIVE-DAY MARITIME HISTORY-THEMED FESTIVAL FEATURING TWO CLASS A HISTORIC SAILING TALL SHIPS AT MALLORY SQUARE DOCK & PLAZA ON MAY 28 THROUGH JUNE 1, 2015 , FROM 10:00 A.M. TO 10:00 P.M., AND THE USE OF THE EAST QUAY WALL FOR DOCKAGE SPACE FOR THE HISTORIC SHIPS ; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN AN ENCLOSED AREA; PROVIDING FOR AN EFFECITVE DATE**

**WHEREAS**, Key West Cultural Preservation Society, Inc. wishes to conduct an event at Mallory Square Dock & Plaza & the East Quay Wall between the hours of 10:00 a.m. and 10:00 p.m. on May 28 through June 1, 2015; and

**NOW THEREFORE, BE IT RESOLVED**, by the City Commission of the City of Key West, Florida;

**SECTION 1.** That the Key West Cultural Preservation Society, Inc. is hereby granted permission to conduct a Five Day Maritime History-themed Festival on the date and during the hours stated above; **PROVIDED** all trash is adequately collected and contained; guarantee indemnifying the City is executed; and provided the organizations meet the terms and conditions set forth by the City Manager.

**SECTION 2.** That pursuant to City of Key West Code of Ordinances, Section 18-86, the consumption of alcoholic beverages is permitted within the barricaded areas of the event.

**SECTION 3.** Use of the City owned East Quay is subject to the Navy granting access across the restricted Truman Annex Harbor.

**SECTION 4.** That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
