A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE ATTACHED THREE-YEAR MUNICIPAL EQUIPMENT LEASE-PURCHASE AGREEMENT 24020 BETWEEN THE CITY AND MOTOROLA SOLUTIONS, INC. AS A SOLE SOURCE PROVIDER, PURSUANT TO CITY CODE 2-797 (1)(b), FOR MOTOROLA HANDHELD RADIOS AND RELATED EQUIPMENT, AS DESCRIBED IN THE ATTACHED LEASE PURCHASE AGREEMENT 24020, IN ACCORDANCE WITH CITY CODE SECTION 2-844 FOR BRAND NAME PURCHASES FOR THE KEY WEST POLICE AND KEY WEST FIRE DEPARTMENTS; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Monroe County Emergency Communications recently evaluated radio communication equipment and selected Motorola as the preferred manufacturer for equipment that is operable on the Project P25 system. Motorola radio equipment is available through the sole source dealer, Motorola Solutions; and

WHEREAS, the lease-purchase of Motorola equipment pursuant to the brand name specifications provisions of Key West Code of Ordinances section 2-844 is permitted; and

WHEREAS, Key West Code of Ordinances section 2-797(1) permits the purchase of goods and services without competition on a sole source basis under certain specified conditions; and

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the attached Municipal Equipment Lease Purchase Agreement 24020 is hereby approved, in accordance with City Code Section 2-844, for the Key West Police Department and the Key West Fire Department, from Motorola Credit Solutions, LLC as a sole source provider pursuant to City Code of Ordinances section 2-797(1).

Section 2: That the City Manager is authorized to execute necessary documents upon consent of the City Attorney.

Section 3: That funds may be budgeted in the City of Key West Capital Improvement Project for Fiscal Year 2018-2019, and FY 2019-2020, as necessary.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
