A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING HUNT FISH GUIDE PERMISSION FOR A FISHING/SPEARFISHING TOURNAMENT OUT OF THE KEY WEST BIGHT AT THE FOOT OF WILLIAM STREET ON AUGUST 5 THROUGH 8, 2010 FROM 10:00 A.M. TO 9:00 P.M.; AUTHORIZING THE CLOSURE OF LAZY WAY LANE FROM 10:00 A.M. TO 9:00 P.M. DURING THE EVENT; AUTHORIZING THE CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE BARRICADED AREA OF THE EVENT; GRANTING AN EXEMPTION FROM THE NOISE CONTROL ORDINANCES PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES ON AUGUST 5 THROUGH AUGUST 8, 2010 FROM 10:00 A.M. TO 11:00 P.M.; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; PROVIDING FOR AN EFFECTIVE DATE

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of Key West Florida;

SECTION 1. The Hunt Fish Guide is hereby granted permission to conduct an event during the hours and location stated above; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; and that organization meet the terms and conditions set forth by the City Manager; and that 25% of gross revenue or \$1,000.00, whichever is greater, shall be donated to a non profit organization.

SECTION 2. That Hunt Fish Guide is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place and time herein described.

SECTION 3. That pursuant to Section 18-86 of the Key West Code of Ordinances, Hunt Fish Guide is hereby granted permission allowing the sale and consumption of alcoholic

beverages within the enclosed area.

SECTION 4. That Hunt Fish Guide will adhere to the recycling plan of the City of Key West.

SECTION 5. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and the Clerk of the Commission.
