An application was received requesting the removal of **(1) Royal Poinciana tree**. A site inspection was done and documented the following:

Diameter: 10.5" (co-dominant trunks)

Location: 30% (wrong tree, wrong place-large tree species growing in a small area between two buildings)

Species: 100% (on protected tree list)

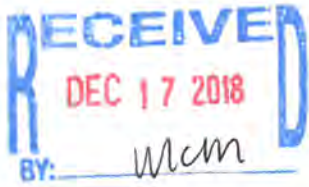
Condition: 40% (poor, codominant trunk structure with a metal pole at base junction, elongated trunk structure.)

Total Average Value = 56%

Value x Diameter = 5.8 replacement caliper inches

Recommendation: Recommend approval of the removal of one (1) Royal Poinciana tree at 1023 White Street to be replaced with 5.8 caliper inches of dicot or fruit trees from approved list, FL#1, to be planted on site or at a donated site.
