A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING A PROCUREMENT TO UPGRADE THE KEY WEST POLICE DEPARTMENT'S COMPUTER AIDED DISPATCH (CAD)/RECORDS MANAGEMENT SYSTEM (RMS) SOFTWARE TO THE PRO SUITE CENTRALSQUARE SOFTWARE PLATFORM; AUTHORIZING ON A SOLE SOURCE BASIS IN ACCORDANCE WITH CITY CODE SECTION 2-797(1), AND SECTION 2-797(4)(b), BEST INTERESTS OF THE CITY, THE PURCHASE OF CENTRALSQUARE PUBLIC SAFETY SOFTWARE IN AN INITIAL AMOUNT NOT TO EXCEED \$270,875.55; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS OR ADJUSTMENTS; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the current version of Central Square CAD/RMS software (OneSolution) has reached its end-of-life. It is necessary to upgrade/migrate software applications used for public safety by the Key West Police Department for CAD/RMS from OneSolution (through Superior, a CentralSquare Technologies Company) to "Pro Suite" CentralSquare (through CentralSquare Technologies, LLC), an upgraded software platform; and

WHEREAS, staff has determined that the Pro Suite package is an improved, accessible and user-friendly subscription software platform. It is cost-efficient and in the best interests of the City to upgrade to this software, rather than migrating to a different vendor; and

WHEREAS, Key West Code of Ordinances section 2-797(1) permits the purchase of goods and services without competition on a sole source basis under certain specified conditions; and

WHEREAS, Key West Code of Ordinances section 2-797(4)(b) further provides "If in the opinion of the city manager exceptional circumstances exist to exempt a purchase from the competitive bid requirements of this subdivision for the best interests of the city, he shall place a resolution before the city commission for approval of such exemption."; and

WHEREAS, the City Manager has recommended the waiver of formal bidding procedures pursuant to section 2-797(4) of the Code of Ordinances;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of the CentralSquare Pro Suite Public Safety Platform at an initial cost not to exceed \$270,875.55, is hereby approved on a sole source basis, and in the best interest of the City, pursuant to sections 2-797(1) and 2-797(4), of the Code of Ordinances is hereby authorized.

Section 2: That this purchase is budgeted for FY 22-23 in infrastructure account No. 101-2101-521-6400.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
