A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING, PURSUANT TO SECTION 2-797(4)(b) OF THE CODE OF ORDINANCES, A TWO-YEAR EXTENSION OF THE "AGREEMENT BETWEEN THE CITY AND HISTORIC TOURS OF AMERICA, INC." FOR THE PROVISION OF SHUTTLE SERVICES FOR CRUISE SHIP PASSENGERS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 07-379, the City Commission awarded the bid of Historic Tours of America, to provide shuttle services for cruise ship passengers for the City of Key West; and

WHEREAS, in Resolution No. 12-317 the City Commission approved the "First Amendment to Agreement," amending certain terms and extending the agreement through June, 2013; and

WHEREAS, in Resolution 15-018 the City Commission ratified a retroactive emergency procurement extending the amended agreement upon negotiated terms, effective through December 31, 2014, plus an additional year, through December, 2015; and

WHEREAS, in October 2015, the City issued ITB #004-16 for cruise ship shuttle services, and received no responses; and

WHEREAS, City staff finds that Cruise Ship Passenger Shuttle Service is necessary, and that HTA is currently the only local business with the capacity to provide this service. Accordingly, staff recommends extension of the contract through December 31, 2017, upon mutually agreeable terms;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That an additional two-year extension of the "Agreement Between the City and Historic Tours of America, Inc." inclusive of terms contained in the previous extensions, is hereby approved, pursuant to section 2-797(4)(b) of the Code of Ordinances.

Section 2: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
