A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE PURCHASE OF ONE BOBCAT TRACK LOADER WITH ACCESSORIES IN THE TOTAL AMOUNT OF \$62,493.92, FROM CLARK EQUIPMENT COMPANY DBA BOBCAT COMPANY, INCLUDING \$54,693.30 OF THE TOTAL AMOUNT PURSUANT TO STATE OF FLORIDA CONTRACT 22101000-15-1, AND \$7,800.62, FOR RELATED ACCESSORIES AND FELLING TRAILER PURSUANT TO SECTION 2-797(4)(B), BEST INTERESTS OF THE CITY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, section 2-797(3) of the Code of Ordinances authorizes purchases pursuant to State government contracts; and

WHEREAS, certain essential accessories for the Bobcat are not offered under the Government contract, but are included in the price quote provided by the vendor;

WHEREAS, the City Manager has determined that the purchase of accessories listed in the attached price quote, including a Felling trailer, is in the best interests of the City pursuant to section 2-797(4)(b) of the Code of Ordinances; and

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of one Bobcat Track Loader with accessories, from Clark Equipment Company dba Bobcat Company, pursuant to State of Florida Contract 22101000-15-1, is hereby authorized in the total amount of \$62,493.92.

Section 2: That \$54,693.30 of the purchase price is authorized pursuant Section 2-797(3) of the Code of ordinances, under State of Florida Contract No. 22101000-15-1, and \$7,800.62 of the purchase price is authorized pursuant to section 2-797(4)(b), best interests of the City.

Section 3: That funding for this purchase is budgeted for FY 15-16 under roads and streets account #102-4102-541-6400.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
