A RESOLUTION OF THE CITY COMMISSION OF THE APPROVING WORK CITY OF KEY WEST, FLORIDA, IN AN AMOUNT NOT TO CHANGE DIRECTIVE 8, \$83,408.00 TO THE CONTRACT EBSARY FOUNDATION COMPANY, FOR NAVY INC. MOLE BULKHEAD 497 REPAIRS, PROJECT OM1201; TRANSFERS; BUDGET NECESSARY APPROVING PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Key West leases from the United States of America through the Department of the Navy a section of the Navy Outer Mole Pier for the specific purpose of cruise ship berthing; and

WHEREAS, in lieu of rent payments to the Navy for use of the Mole Pier, the City has agreed to perform certain in-kind projects, including the work contemplated in ITB 12-007: Repairs to Navy Mole Bulkhead 497; and

WHEREAS, in Resolution No. 12-144, the City Commission approved the original contract and in Resolution 12-258 the City Commission ratified Work Change Directive 6; and

WHEREAS, during the course of construction, engineers have determined that additional work is necessary to ensure the successful completion of the project; and

WHEREAS, the U.S. Navy has approved Change Directive 8, and City staff recommends approval by the City Commission; and

WHEREAS, the cost of this project is covered as an in-kind service through the Navy Mole Lease fund;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That Work Change Directive 8, Project OM1201: Bulkhead 497 Repairs Outer Mole Pier is hereby ratified and approved in an amount not to exceed \$83,408.00.

Section 2: That the City Manager is authorized to execute any contractual documents, with the advice and consent of the City Attorney, that are consistent with Work Change Directive 8, as approved herein.
