WHEREAS, The Key West Art Center anticipates that over 10,000 people will be participating in the event.

SECTION 2. That the Key West Art Center is hereby granted permission for the closure of Whitehead Street between Greene Street and Eaton Street including Caroline Street on the date and during the hours stated above.

SECTION 3. That the Key West Art Center will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that

they will be placed side by side.
