A RESOLUTION OF THE TREE COMMISSION OF THE CITY OF KEY WEST, FLORIDA, RECOMMENDING THAT THE CITY COMMISSION ADJUST, PURSUANT TO SECTION 110-327(7)(a) OF THE CODE OF ORDINANCES, THE STANDARD DONATION [IN-LIEU FEE], TO INCREASE REPLACEMENT INCHES FOR CANOPY TREES FROM \$150.00 PER CALIPER INCH TO \$200.00 PER CALIPER INCH; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Tree Commission recognizes that canopy trees are essential to the beauty, comfort, sustainability and history of Key West; and

WHEREAS, the Poinciana tree is considered a canopy tree; and

WHEREAS, Section 110-327 of the Code of Ordinances provides specific criteria to support approval of a tree removal permit application; and

WHEREAS, pursuant to Section 110-327(7)(a) of the Code of Ordinances, the City Commission can amend the standard donation [in-lieu fee] for replacement inches by Resolution; and

NOW, THEREFORE, BE IT RESOLVED BY THE KEY WEST TREE COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the Tree Commission recommends that the City Commission should adjust the standard donation [in-lieu fee] set forth in Section 110-327 of the Code of Ordinances for canopy trees from \$150.00 per caliper inch to \$200.00 per caliper inch.

Section 2: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Tree Commission.
