A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING ATL PRODUCTIONS AND EL SIBONEY TO CONDUCT THE FLORIDA KEYS LATIN FESTIVAL AT BAYVIEW PARK ON SATURDAY, MARCH 22ND, 2025 FROM 11:00 A.M. TO 8:00 P.M. AND SUNDAY, MARCH 23RD, 2025 FROM 11:00 A.M. TO 5:00 P.M (SET UP THURSDAY, MARCH 20, 2025 AND FRIDAY, MARCH 21ST, 2025 AND TEAR DOWN ON SUNDAY, MARCH 23RD, 2025); PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE ENCLOSED AREA; PROVIDING FOR AN EFFECTIVE DATE

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of Key West Florida.

SECTION 1. That In Resolution 19-174, the City Commission directed the city Manager to "develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the local government for the provision of good or services, unless such use is otherwise preempted by law."

SECTION 2. "That the vendor/lessee/licensee acknowledges the City's concern about the negative environmental impact of using disposable polystyrene products, which are neither readily recyclable nor biodegradable. Vendor/Lessee/licensee/contractor

therefore commits to refrain from the use of polystyrene/plastic straws, bags, plastic utensils and "To go" packages for food or products sold on any property leased from the City."

SECTION 3. That ATL Productions and El Siboney are hereby granted permission to conduct a Latin Festival on the day and during the hours stated above; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; and that organization meets the terms and conditions set forth by the City Manager.

SECTION 4. That pursuant to Section 18-86 of the Key West Code of Ordinances, ATL Productions and El Siboney are hereby granted permission allowing the sale and consumption of alcoholic beverages within the enclosed area.

SECTION 5. That ATL Productions and El Siboney must post the required notice regarding prohibition of purchase and sale of alcoholic beverages to persons under 21 years of age.

SECTION 6. That ATL Productions and El Siboney will adhere to the recycling plan of the City of Key West, and that (1) recycling container for everyone (1) trash barrels will be used and that they will be placed side by side.

SECTION 7. That the applicant acknowledges this authorization may be revoked by this Commission, or the City Manager, due to exigent circumstances such as the resurgence of COVID-19 in the Community.

SECTION 8. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and the Clerk of the Commission.
