A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE PURCHASE OF 10 NEW HANDHELD MOTOROLA RADIOS AND RELATED ACCESSORIES FROM MOTOROLA SOLUTIONS, INC. IN AN AMOUNT NOT TO EXCEED \$62,631.40, AS DESCRIBED IN THE ATTACHED PRICE QUOTE, AS A SOLE SOURCE PROVIDER, PURSUANT TO CITY CODE 2-797 (1) (b) IN ACCORDANCE WITH CITY CODE SECTION 2-844 FOR BRAND NAME PURCHASES FOR THE KEY WEST EMERGENCY OPERATIONS CENTER; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Key West Fire Department and Police Department radio fleet is comprised mainly of Motorola APX series handheld radios, which are compatible with Monroe County's 800MHz system, operate on the P25 two-way radio system, and are compatible with Monroe County Emergency Communications; and

WHEREAS, the procurement of ten Motorola radios and related equipment for the Key West Emergency Operations Center complies with the City of Key West's Comprehensive Emergency Management Plan by improving emergency communications, to support planning, response and flexibility in meeting the needs of emergency preparedness and incident management; and

WHEREAS, the purchase of Motorola equipment pursuant to the brand name specifications provisions of Key West Code of Ordinances section 2-844 is permitted; and

WHEREAS, Key West Code of Ordinances section 2-797(1) permits the purchase of goods and services without competition on a sole source basis under certain specified conditions; and

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of 10 Motorola radios and related accessories from Motorola Solutions, Inc. in an amount not to exceed \$62,631.40, as described in the attached price quote, as a sole source provider, pursuant to City Code 2-797(1)(b), and in accordance with City Code Section 2-844 for brand name purchases for the Key West Emergency Operations Center is hereby approved.

Section 2: That the City Manager is authorized to execute necessary documents upon consent of the City Attorney.

Section 3: That funds are budgeted in the City of Key West General Fund/Emergency Preparedness fund 001-2501-525-6400. Any necessary budget transfers or adjustments are hereby authorized.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
