

A parcel of land on the Island of Key West and is a portion of Catherine Street adjacent to Square 6, Tract 13, as shown on Watson's Subdivision of said Tract, which is recorded in Deed Book "I", Page 209, of the Public Records of Monroe County, Florida, said parcel being more particularly described by metes and bounds as follows:

described by metes and bounds as follows: COMMENCE at the intersection of the NW'ly right of way line of Catherine Street with the NE'ly right of way line of Grinnell Street and run thence NE'ly along the NW'ly right of way line of the said Catherine Street for a distance of 66.98 feet to the SW'ly face of an existing concrete block wall, said point also being the Point of Beginning; thence continue NE'ly along the NW'ly right of way line of the said Catherine Street for a distance of 42.44 feet to the SW'ly face of an existing concrete block wall; thence SE'ly and at right angles for a distance of 10.40 feet; thence SW'ly and at right angles for a distance of 10.40 feet back to the Point of Beginning, containing 441 square feet, more or less.


