An application was submitted to remove 77 sf of mangroves from the back of this property. Heavy erosion has caused foundation settling and sinking. The erosion has caused a large portion of the patio around the pool to tilt towards the canal. The pool is likely leaking water due to the erosion. The erosion is severe and needs significant repair and restoration. Removing 77 square feet of mangroves is minimal considering 168 square feet of mangroves are to remain. Riviera and Sunrise Dr. have over a mile of seawalls to protect properties from coastal erosion. Of all the residences on this canal, this property sits directly across from the Riviera Canal boat ramp. This property should be given special consideration due to the heavy prop wash from boats using the boat ramp. We humbly ask for your consideration in this unique case.
