## RESOLUTION NO.

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING QUEPASA KW, INC. TO CONDUCT THE PET MASQUERADE AT THE TRUMAN WATERFRONT AMPHITHEATRE AS A FUNDRAISER FOR LOWER KEYS FRIENDS OF ANIMALS ON WEDNESDAY, OCTOBER 25, 2023, FROM 5:00 P.M. TO 9:00 P.M; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN AN ENCLOSED AREA; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Quepasa KW, Inc. wishes to conduct the Pet Masquerade at the Truman Waterfront Amphitheatre between the hours of 5:00 p.m. to 9:00 p.m. on Wednesday, October 25, 2023.

**NOW THEREFORE, BE IT RESOLVED,** by the City Commission of the City of Key West, Florida.

SECTION 1. That in Resolution 19-174, the City Commission directed the City Manager to "develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the provision of good or services, unless such use is otherwise preempted by law."

SECTION 2. That the vendor/lessee/licensee acknowledges the City's concern about the negative environmental impact of using disposable polystyrene products, which are neither readily recyclable nor biodegradable. Vendor/lessee/licensee/contractor therefore commits to refrain from the use of distribution of single-use polystyrene/plastic items, including but not limited to single-use polystyrene/plastic straws, bags, plastic utensils and "to go" packages for food or products sold on any property leased from the City."

SECTION 3. Quepasa KW, Inc. is hereby granted permission to conduct the Pet Masquerade on the date and during the hours stated above; PROVIDED all trash is adequately collected and contained; guarantee indemnifying the City is executed; and provided the organizations meet the terms and conditions set forth by the City Manager.

**SECTION 4.** That pursuant to Section 18-86 of the Key West Code of Ordinances, Quepasa KW, Inc. is hereby granted permission allowing the sale and consumption of alcoholic beverages within an enclosed area.

**SECTION 5.** That Quepasa KW, Inc. must post the required notice regarding prohibition of purchase and sale of alcoholic beverages to persons under 21 years of age.

**SECTION 6.** That Quepasa KW, Inc. will adhere to the recycling plan of the City of Key West, that one (1) recycling container for everyone (1) trash container will be used and that they will be placed side by side.

**SECTION 7.** Quepasa KW, Inc. will be responsible for the rental fee of five hundred \$(500.00) dollars plus tax. In addition, Quepasa KW, Inc. will be required to pay the Police, Fire and Community Services before the event.

**SECTION 8.** That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
