A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING AND AUTHORIZING THE EXECUTION OF THE ATTACHED AGREEMENT BETWEEN THE CITY OF KEY WEST, FLORIDA, AND SUPER BOAT INTERNATIONAL PRODUCTIONS, INC. FOR THE CITY OF KEY WEST WORLD CHAMPIONSHIP RACE FROM 2014 THROUGH 2018; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES ON CITY PROPERTY/RIGHTS-OF-WAY AT THE TRUMAN WATERFRONT PARK BY NOT-FOR-PROFIT ORGANIZATIONS TO BE SELECTED BY SUPER BOAT INTERNATIONAL PRODUCTIONS, INC.; AUTHORIZING THE CITYMANAGER TO ISSUE A LETTER OF NO OBJECTION TO THE DEPARTMENT OF BUSINESS AND REGULATION, ALCOHOL AND TOBACCO DIVISION FOR THE SALE OF ALCOHOLIC BEVERAGES EACH DAY BY NOT-FOR-PROFIT ORGANIZATIONS ON PUBLIC PROPERTY; GRANTING AN EXEMPTION FROM THE NOISE CONTROL ORDINANCE PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES DURING THE BOAT RACES; PROVIDING FOR AN EFFECTIVE DATE

BE IT RESOLVED by the City Commission of the City of Key West, Florida, as follows:

Section 1. That the attached Agreement between the City of Key West and Super Boat International Productions, Inc. is hereby approved. The City Manager is hereby authorized and directed to execute the Agreement on behalf of the City of Key West, and the City Clerk is hereby authorized and directed to attest to his signature and affix the Seal of the City thereto.

Section 2. That pursuant to Section 18-86 of the Key West Code of Ordinances, permission is granted to allow the sale of alcoholic beverages within the Truman Waterfront Park.

Section 3. That the Association is hereby granted an exemption from the sound control ordinance under Section 6-86 of the Key West Code of Ordinances for an event that will take place at the place and time as herein described.

Section 4. That the City Manager is hereby directed to issue letters of no objection to the Department of Business Regulation, Alcohol and Tobacco Division, for not-for-profit organizations each day to sell alcohol on private property.

Section 5. That Super Boat International Productions, Inc. shall designate and identify the placement of all boats and vendors in accordance with the Truman Waterfront Park Master Plan, and its boundaries.

Section 6. That Super Boat International Productions, Inc. will adhere to the recycling plan of the City of Key West and that (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.

Section 7. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
