DETAIL WHAT HAPPENED, AND MOST
IMPORTANTLY, WHAT SHOULD NOT HAVE
HAPPENED. I'VE INCLUDED THE OTHER
OFFICERS IN THIS COMPLAINT SINCE THEY
DID NOT SPEAK UP AND DO THE
RIGHT & LAWFUL THING. OFFICER STOCKTON
LIED THAT HE HAD A BODY CAM ON
AMONG OTHER BAD THINGS THAT WERE
TAKING PLACE THAT NIGHT. I SAID TO
NOT SEARCH MY VEHICLE, IT WAS SEARCHED
ANYWAY WITH THE 'EXCUSE' IT WAS
BEING TOWED (FROM MY PERSONAL PARKING
SPACE AT PLACE I LIVED) AND OFFICES
NEEDED TO INVENTORY ITEMS (I ASKED FOR

THE PROBLEM IS THERE IS MUCH MORE TO BRING OUT WITH OFFICER DAVIS (TOTALLY UNNECESSARILY PUTTING ME FROM MY VEHICLE AS I WAS ATTEMPTING TO EXPLAIN MY PHYSICAL LIMITATIONS AND WANTED TO DEAL WITH THE OFFICER THAT INITIALLY STOPPED ME WITHOUT PROBABLE CAUSE, OR EVEN REASONABLE SUSPICION.)

TO WHOM IT MAY CONCERN, PLEASE DON'T BRUSH THIS OFF, I'D LOVE TO FINALLY BE FREE OF MY EMOTIONAL ANGUISH, PERHAPS EVEN PHYSICAL PAIN IN THE FUTURE, ALSO SOMEHOW DEAL WITH THE EMBARRASSMENT, TOO. (MY PICTURE IS STILL ABLE TO BE ACCESSED ON THE INTERNET.)
