EXECUTIVE SUMMARY

RE: Comm. Lopez Resolution to waive back due Sewer, Storm Water, Solid Waste fees

for 326 Truman Avenue.

Action statement:

A proposed resolution to waive all back due sewer, storm water, and solid waste fees that are currently in arrears for the property located at 326 Truman Ave. This Resolution is sponsored by Commissioner Lopez.

Background: The property at 326 Truman Avenue contains 2 units; only one of which was historically recognized by the City of Key West. Pursuant to a Code Compliance case, the owner of the property sought to obtain a Lawful Unit Determination from the Planning Department in order to bring the issue of lawful units at the property into compliance. A favorable determination was made in the property owner's favor, however, as per Sec. 14-1: "The city and its agencies, departments, boards and authorities shall not issue any permit, approval, development order, variance, or certificate on any lot or parcel of property in the city until all fees, fines, charges and assessments of any nature due or accruing to the city have been paid on the subject parcel or lot." Therefore, since \$14,139.86 is currently due and owing on the property, the property cannot receive the Lawful Unit Determination until said fees are paid (or waived).

Options:

- 1. Approve the proposed waiver of back due sewer, storm water, and solid waste fees amounting to \$14,139.86 thereby allowing the subject property to receive its Lawful Unit Determination
- 2. Deny the waiver of fees and the Code Compliance case will proceed accordingly.

Recommendation:

Neither the Legal Department, nor city management can recommend approval of this Resolution as it does not conform to the City's overall best financial interests and consistent past practices.
