AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AMENDING AND UPDATING SEC. 74-387. - EQUIVALENT STORMWATER UNIT (ESU) THE ANNUAL SEWER RATE, OF THE CODE OF ORDINANCES IN THE CITY OF KEY WEST; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Key West finds that it is necessary to adjust the annual sewer rate that is above the CPI, and that it is necessary to do so by ordinance; and

WHEREAS, an amendment to the rate established in section 74-387 of the Code of Ordinances will promote the safety and welfare of the citizens and visitors of the City of Key West.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the annual stormwater rate, set forth in Section 74-387 of the Code of Ordinances are amended as follows:

<u>Sec. 74-387</u>. - Equivalent stormwater unit (ESU) rate.

The <u>annual</u> user fee charged on each ESU shall be \$171.31 \$7.80. This rate may be adjusted by resolution of the city commission each October 1, by up to 100 percent of the percentage increase in the CPI-(U), the U.S. City Averages (as of June). The city commission shall enact an ordinance amendment to this section in order to increase the ESU in excess of the CPI.

Section 2: That this Ordinance shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
