





Narrative

NARRATIVE OF INCIDENT

Officer Osborne was conducting a battery investigation involving a friend of both of the Inghams and another gentleman. While officers were conducting the investigation, Ingham Jr., continued to approach officers, refused to step back and follow lawful commands and proceeded to take his phone out and start filming. Officers continued to tell Ingham as well as his friends to back up and he refused, telling officers they would not do anything. Ingham Jr., proceeded to take off his chain and his earring, a common indication that an individual is about to fight, and took an aggressive stance at officers. At this point, Officer Osborne attempted to place Ingham Jr., into handcuffs but he continued to resist. Ingham Sr., then approached officers and struck Officer Osborne in the head with a glass beer bottle. Officer Osborne delivered a single closed fist strike to the right facial area of Ingham, Sr. Rick's security assisted and Ingham Sr., was placed in handcuffs. Ingham Jr., continued to resist officers' efforts to place him in handcuffs, and he was drive stunned. Ingham Sr., was transported to the hospital by Rescue and received stitches for a laceration to his eye area. Ingham Jr., had a small laceration on his lip.
