A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA APPROVING "PUBLIC TRANSPORTATION GRANT AGREEMENT" (PTGA) #G3048 BETWEEN THE FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) AND THE CITY OF KEY WEST, FLORIDA AS ATTACHED HERETO AND MADE A PART HEREOF, FOR SFY2026 SECTION 5311 OFF-CYCLE FUNDS ASSISTANCE FOR THE PURCHASE OF TRANSIT MAINTENANCE AND OPERATIONAL EQUIPMENT IN AN AMOUNT NOT TO EXCEED \$304,278.00; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY RELATED DOCUMENTS AND BUDGET TRANSFERS/AMENDMENTS, SUBJECT TO ALL ALLOCATIONS AND IN ACCORDANCE WITH THE GRANT, UPON THE ADVICE AND CONSENT OF THE CITY ATTORNEY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in Resolution 25-138, the City Commission authorized certain City staff to apply for grant funding and to execute and submit grant documentation through the Federal Transit Administration (FTA) and Florida Department of Transportation (FDOT); and

WHEREAS, the FTA Section 5311 Off-Cycle grant funds will assist with the purchase of transit maintenance and operational equipment in amount not to exceed 100% of allocated funds or \$304,278.00 of total project cost;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the City Commission hereby approves "Public Transportation Grant Agreement (PTGA)#G3048" between the Florida Department of Transportation (FDOT) and the City of Key West,

Florida, as attached hereto and made a part hereof, for FTA Section 5311 Off-Cycle funding assistance to purchase maintenance and operational equipment in an amount not to exceed \$304,278.00 (100% of total project cost).

Section 2: That the City Commission hereby authorizes the City Manager to execute any necessary related documents to include amendments, renewals and extensions, and budget transfers/amendments, subject to all allocations and appropriations in accordance with such grant and upon the advice and consent of the City Attorney.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
