**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING FINNEGAN'S WAKE TO CONDUCT ST. PATRICK'S DAY CELEBRATION ON MARCH 17, 2011, FROM 9:00 A.M. TO MIDNIGHT; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE CLOSURE OF JAMES STREET BETWEEN GRINNELL AND MARGARET STREETS FROM 9:00 A.M. TO MIDNIGHT; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE ENCLOSED AREA; PROVIDING FOR AN EFFECTIVE DATE**

**NOW, THEREFORE, BE IT RESOLVED** by the City Commission of the City of Key West Florida;

**SECTION 1.** That Finnegan's Wake is hereby granted permission to conduct St. Patrick's Day Celebration on the day and during the hours stated above; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; and that organization meet the terms and conditions set forth by the City Manager; and 25% of gross revenue or \$1,000.00, whichever is greater, shall be donated to the Shriners/Masons.

**SECTION 2.** That Finnegan's Wake is hereby granted permission for the closure of James Street between Grinnell and Margaret Streets on the date and during the hours stated above.

**SECTION 3.** That pursuant to Section 18-86 (b) of the Key West Code of Ordinances, Finnegan's Wake is hereby granted permission allowing the sale and consumption of alcoholic beverages within the enclosed area.

**SECTION 4.** That Finnegan's Wake event is verified by staff with a follow up that 25%

of the net proceeds go to charity.

**SECTION 5.** That Finnegan's Wake will adhere to the recycling plan of the City of Key West.

**SECTION 6.** That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and the Clerk of the Commission.
