An application was received requesting the removal of **(1) Gumbo Limbo tree**. A site inspection was done and documented the following:

Tree Species: Gumbo Limbo (*Bursera simaruba*)

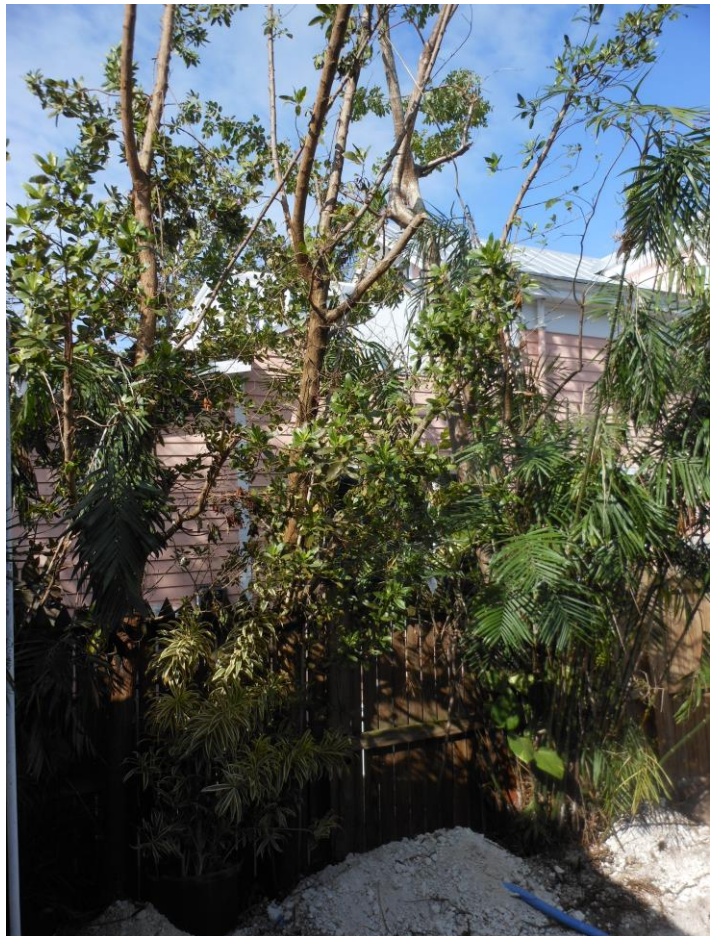
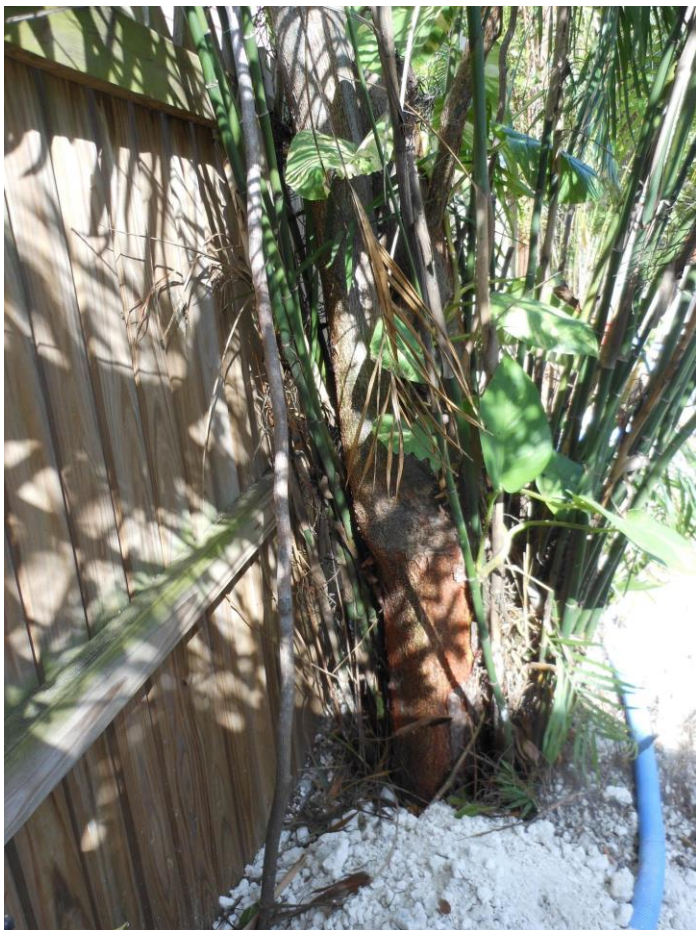

Diameter: 10.1" (multiple trunks)

Location: 60% (growing very close to fence line-tree found during cleanup and removal of tall Ficus benjamina)

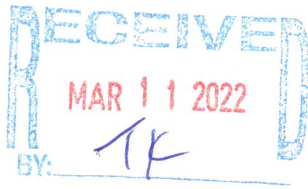
Species: 100% (on protected tree list)

Condition: 50% (overall condition is fair to poor, young tree with poor structure-codominant trunk with included bark.)

Total Average Value = 70%

Value x Diameter = 7 replacement caliper inches

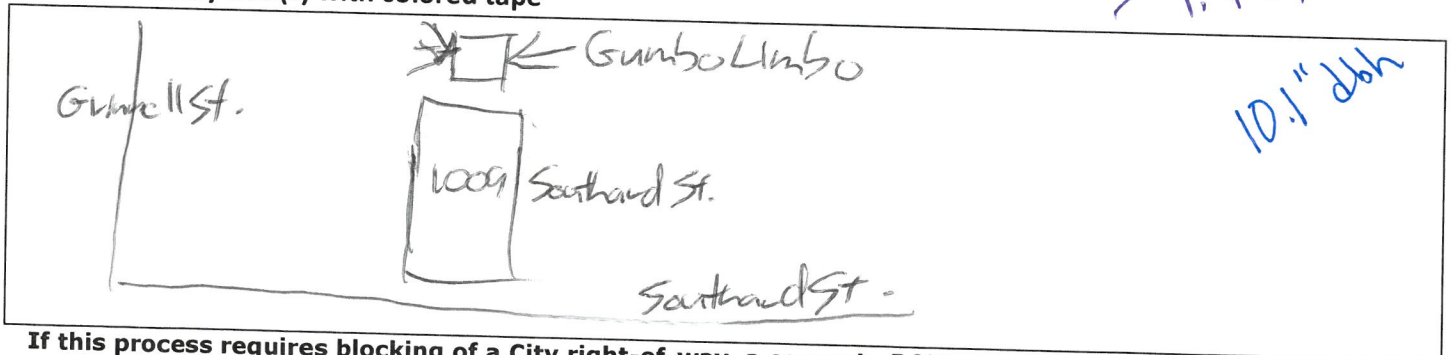
