On Friday, July 26, 2019 at approximately 1533 hours, I (Ofc. A. Rodriguez) responded to K-Mart, 2928 N. Roosevelt Blvd. in reference to a shoplifter in custody of Loss Prevention.

Upon arrival, I met with Kabinet Bangoura and saw a white female later identified as Heidi O'Brien on a cellular phone. I asked Bangoura if O'Brien was the female in his custody and he told me she was. I asked O'Brien to hang up the phone and she ignored my request. I then told O'Brien to hang up the phone and that I would make her hang up if she refused to do so. O'Brien continued to refuse to hang up and told whoever she was speaking to our location.

I gained control of O'Brien's right wrist and she immediately tensed her arm and attempted to pull it away from me. I used the wall and placed O'Brien's body against (facing it) and retrieved my handcuffs. O'Brien was continuing to attempt to pull her arm away from me. I gave O'Brien loud verbal commands to stop resisting and was able to place her into handcuffs. While I was handcuffing her, O'Brien told me she was pregnant. I explained to her that it would benefit her to stop resisting as I handcuffed her.

Incident to arrest, I searched O'Brien's bag that was looped onto her shoulder. Inside of the bag I located three DVD movies still plastic-wrapped, lip gloss, a wall charger still in plastic packaging, and children's socks with the cardboard packaging still intact. There was no receipt for the items within O'Brien's purse.

I instructed O'Brien to sit down and met with Bangoura again.

Bangoura told me he was near the front of the store when O'Brien asked for assistance loading a crib into her vehicle. Bangoura told me he met with O'Brien and asked for her receipt to verify the purchase. Bangoura said O'Brien was unable to produce a receipt and told Bangoura it was a layaway item her husband setup. Bangoura told me he checked the computer system and was unable to locate her husband's name. Bangoura went a step further and checked the SKU of the crib and told me the last time it was on layaway was two months prior.

Bangoura told me he had prepared video surveillance of the theft of the crib. Bangoura told me he was unaware of the theft of the items within O'Brien's purse. Bangoura showed me the video of O'Brien walking with a crib, mattress, and crib sheet set from the back of the store towards the front, and then out of the front door, passing all points of sale. O'Brien did not make an attempt to pay for the items within her cart or her purse.

Bangoura told me he would track O'Brien on the video surveillance and capture the theft of the other items. Bangoura told me he would prepare a video copy of the surveillance on a DVD. I went to K-Mart and retrieved the copy of the DVD from Bangoura after the arrest.

Bangoura provided me with a copy of the receipt showing the value of all items. The value of all items O'Brien attempted to steal was \$410.60.

I transported O'Brien to the MCDC without incident.

My AXON BWC and COBAN were activated for this incident.

I later submitted the receipt and DVD into KWPD Property as evidence.

O'Brien willfully and unlawfully resisted my lawful orders (while in uniform with clearly visible agency insignia) and physically resisted my attempts to handcuff her by pulling away and tensing her arm in an attempt to not be placed into handcuffs, which is a violation of FSS 843.02.

O'Brien deprived K-Mart of the benefit of the items for sale she had in her purse and cart by willfully walking past all points of sale in an attempt to take the items without paying for them, valuing a total of \$410.60, which is a violation of FSS 812.014(2)(C)(1).
