

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, RATIFYING AN EMERGENCY PURCHASE APPROVED BY THE CITY MANAGER IN EXCESS OF \$20,000 AS ALLOWED UNDER SECTION 2-797(2) OF CITY'S CODE OF ORDINANCES, FOR THE PROCUREMENT OF TWO RESTROOM TRAILERS IN THE AMOUNT OF \$77,466.00 FROM PORTABLE RESTROOM TRAILERS, LLC; AUTHORIZING NECESSARY BUDGET TRANSFERS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, structural hazards prohibit the safe use of existing rest room facilities at the Frederick Douglass Gymnasium; and

WHEREAS, a chemical toilet, with no hand washing facilities provides the only current room facilities at the existing Police Athletic League Gymnasium at Truman Annex; and

WHEREAS, in accordance with 2010 Florida Building Code, Section 403, the City of Key West facilities must meet minimum sanitation guidelines; and

WHEREAS, staff obtained price quotes from three vendors for two temporary restroom facilities, and Portable Restroom Trailers, LLC provided the lowest bid and timely service; and

WHEREAS, the City Manager acted without delay, utilizing emergency powers authorized under Section 2-797(2) of the City's Code of Ordinances, to procure temporary rest room facilities to bring the affected facilities up to Code; and

WHEREAS, Section 2-797(2) of the City's Code of Ordinances requires the City Commission to ratify such emergency purchases at its next scheduled meeting.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSON OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: The City Commission, in accordance with Section 2-797(2) of the City of Key West Code of Ordinances, hereby ratifies the City Manager's emergency authorization for the procurement in the amount of \$77,466.00 from Portable Restroom Trailers, LLC for two restroom trailers.

Section 2: That necessary a budget transfer from account 001-1900-519.98-01 to 001-1905-519-64 is authorized.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the clerk of the commission.
