Original Narrative By Corey Vanderhoof, 07/05/25 03:01

On Saturday 07/05/2025 at approximately 0017 hours, I (Ofc. Vanderhoof) was dispatched to 3820 N Roosevelt Blvd in reference to a possible verbal argument.

I met with Janelle Martin (Witness) who informed me that a male and his girlfriend were being confrontational and aggressive with the hotel staff and demanding that they be escorted to their rooms.

Case 25003616 Page 2 of 5 The male and female continued to argue with the hotel staff, and as they left the male kicked one of the sliding doors to the hotel, damaging it, to where it does not work anymore. The door was kicked off the tracks and bent facing outwards.

I also spoke with a member of the hotel staff, identified as Alena Lembach (Witness) who at the time was working at the front desk. Lembach also stated the same thing. Lembach stated that the male and female were very confrontational due to not being escorted to their rooms and the male kicked the front door causing it to be damaged. Lembach stated that it would cost approximately \$2,000 to fix the door and that the hotel wanted to press charges as well as have the male and female evicted from the property.

I was able to take pictures of the damage done to the door. I uploaded the pictures to Evidence.com.

The hotel security guard escorted Sgt. Kouri, Ofc. Adorno, and I to room 120 where the guests were staying. While walking to the room, the hotel security pointed out a male and female sitting on the curb and stated "that's him" while pointing to the male.

While talking to the male, identified as Lane Jenkins (Arrestee), he stated that he had no idea how the door sustained the damage that it got. Jenkins stated that I could do what I had to do. Jenkins became very fidgety and unsteady, by standing up and moving around. Ofc. Adorno and I told Jenkins to put his and hands behind his back and went to place Jenkins in handcuffs, while doing so Jenkins began pulling away and attempting to get away from us while also trying to headbutt Ofc. Adorno. Ofc. Adorno and I brought Jenkins to the ground in a controlled manner in attempt to gain better control of Jenkins to place him in handcuffs. Jenkins continued to attempt to pull away and refusing to put his hands behind his back even after numerous commands to do so by Sgt. Kouri, Ofc. Adorno and I. I deployed my AXON taser and warned Jenkins if he did not put his hands behind his back, he would be tased. Jenkins continued to refuse to do so. I drive stunned Jenkins in the lower left part of his back for a full 5 second cycle. Jenkins then put his left hand behind his back, however, he refused to put his right hand behind his back. I again warned Jenkins if he did not put his right hand behind his back, he would be tased again. Jenkins continued to refuse to obey my commands. I drive stunned Jenkins in the lower right part of his back for another full 5 second cycle. Jenkins finally cooperated and put his hand behind his back. I was able to handcuff Jenkins behind his back.

Ofc. Adorno and I escorted Jenkins to my patrol vehicle where he was searched at the front of the vehicle.

While trying to put Jenkins in the back of my patrol vehicle he again became combative and refused to enter the vehicle. I was able to get Jenkins into the back of the vehicle but while doing so, Jenkins kicked me in my left leg and continued to kick at me. Sgt. Kouri brought Jenkins out of my patrol vehicle and Jenkins was again taken to the ground in attempt to gain control of him again. Due to the nature of Jenkins and his kicking, I requested a unit with a hobble restraint device, Sgt. Peters arrived at our location with one. Jenkins however decided to calm down and listen to the commands to stop kicking and was placed back in my patrol vehicle.

Jenkins was transported to the Lower Keys Medical Center for a medical clearance due to having multiple abrasions and being tased.

After Jenkins was medically cleared, he was transported to the Monroe County Detention Center with no further incident.

Based on the facts and evidence, I believe there is probable cause that on 07/05/2025, Lane Jenkins

did knowingly and intentionally violate F.S.S. 784.07 Battery of a Law Enforcement Officer, by actually and intentionally kicking me in my left leg while trying to preform my lawful duties, after arriving on scene in a marked KWPD SUV and wearing my KWPD class B uniform making me easily recognizable as a police officer.

Based on the facts and evidence, I believe there is probable cause that on 07/05/2025, Lane Jenkins did knowingly and intentionally violate F.S.S. 843.01 Resisting with Violence, by attempting to headbutt and kick Sgt. Kouri, Ofc. Adorno, and I while refusing to put his hands behind his back, after numerous commands to do so, while we were engaged in our legal, lawful duties as uniformed law enforcement officers.

Based on the facts and evidence, I believe there is probable cause that on 07/05/2025, Lane Jenkins did knowingly and intentionally violate F.S.S. 806.13-3 Criminal Mischief \$1,000 or Greater by purposefully kicking the lobby doors at 3820 N Roosevelt Blvd, causing the door to bend outwards and not work anymore. Hotel staff stated the damage would cost approximately \$2,000 to fix.

My BWC was active for the encounter. I uploaded my BWC footage to Evidence.com.

Supplemental Narrative By David Kouri, 07/05/25 20:38

On Saturday July 5th 2025 at approximately 0020 hours, I (Sgt. Kouri) responded to 3820 N Roosevelt Boulevard in reference to a verbal argument.

Upon my arrival, Ofc. Vanderhoof and Ofc. Adorno were speaking with potential victims and witnesses in the hotel lobby. As I entered the hotel lobby, I could see the sliding entrance door was removed from the hinges and was clearly damaged.

A hotel security guard escorted Ofc. Vanderhoof, Ofc. Adorno, and I toward room 120 where the suspect was registered and staying. While walking to the room, the hotel security pointed out a male and female sitting on the sidewalk/curb in the front of the hotel and identified the male as the suspect.

I observed Ofc. Vanderhoof and Ofc. Adorno speaking with the suspect (Jenkins), who was not being cooperative or answering simple questions. Jenkins was agitated and stood up and began pacing and showing physical signs indicative of preparing to become combative or flee on foot. The Officers attempted to handcuff Jenkins, who began to physically resist by pulling away, pulling his arms in front of him, and by attempting to head-butt Ofc. Adorno. The Officers took Jenkins to the ground in a controlled manner, where he continued to physically fight and actively resist. Ofc. Adorno was attempting to gain physical control of Jenkins' legs, Ofc. Vanderhoof was positioned near his torso, and I was positioned near his shoulders and head. Jenkins was given multiple verbal commands to stop resisting and to place his hands behind his back. Jenkins continued to fight and resist. Ofc. Vanderhoof delivered a "drive stun" with his department issued TASER. Jenkins placed one arm behind his back, however would not place his other arm behind his back and continued fighting. Ofc. Vanderhoof delivered a second "drive stun" to Jenkins' lower back, at which time he complied and placed his hands behind his back.

Ofc. Vanderhoof and Ofc. Adorno escorted Jenkins to Ofc. Vanderhoof's patrol vehicle, where he was searched and then placed inside.

As Jenkins was placed into the rear of the patrol vehicle, he continued to resist and began to physically fight again. Jenkins began violently kicking at Ofc. Vanderhoof, striking him in the upper thigh area, with multiple missed kicks. Due to his extremely combative nature and the Officers not being able to properly and safely secure him in the patrol vehicle (seat belted), I removed him from the vehicle and placed him back on the ground in a controlled manner. on the ground I continued to give Jenkins clear verbal commands and directions. After a brief struggle and several more direct verbal commands, Jenkins agreed that the fighting would cease and agreed to comply and get into the patrol vehicle. I lifted Jenkins from the ground and placed him back into the patrol vehicle.

Jenkins was transported to the Lower Keys Medical Center for a medical clearance due to the use of the TASER. Sgt. Peters was on scene for RRI documentation.

After Jenkins was medically cleared, he was transported to the Monroe County Detention Center with no further incident.

My BWC was active and later downloaded at KWPD.

Supplemental Narrative By Samuel Adorno, 07/05/25 21:53

On July 5, 2025, at approximately 0022 hours, I (Ofc. Adorno) responded to 3820 N Roosevelt Blvd (Blue Flamingo), as a back-up unit reference a guest throwing a shoe and causing property damage.

Upon arrival, I met with the hotel's security and was advised an intoxicated couple became irate inside the main lobby, causing a scene. The security then advised me, while the couple was leaving the main lobby, the male kicked the main lobby's sliding door outward, breaking its frame.

Shortly after, Ofc. Vanderhoof and I were able to locate the male individual, sitting on a curb on the east side of the property. Ofc. Vanderhoof began to ask the male what occurred, with the male stating "I don't know". Ofc. Vanderhoof asked once again about the sliding door, with the male stating "I don't know". The male then became belligerent and began to raise his voice with Ofc. Vanderhoof and myself. The male was later identified as Lane Jenkins. While speaking with Jenkins, Jenkins began to stand up and pace back and forth between Ofc. Vanderhoof and myself. Due to his demeanor changing and behavior, I grabbed Jenkins left arm to place him in handcuffs. Jenkins immediately pulled away, attempting to square his body in my direction. At this time, Ofc. Vanderhoof and myself grabbed both arms of Jenkins and guided his body toward the ground. Jenkins began to curl up, into a fetal position, in an attempt to break away from our grips. Jenkins continued to push off a nearby wall with his feet, as Ofc. Vanderhoof and I advised him to stop resisting. Ofc. Vanderhoof then advised Jenkins he would be tased if he continued. Jenkins continued to pull his hands and feet away from us. At this time, Ofc. Vanderhoof delivered two drive-stuns to the sides of Jenkins body (see report for more information).

Ofc. Vanderhoof was able to handcuff Jenkins shortly after. While escorting Jenkins to Ofc. Vanderhoof's patrol vehicle, Jenkins continued to pull away. While placing Jenkins inside the vehicle, Jenkins kicked Ofc. Vanderhoof multiple times to his lower extremities. Jenkins was escorted outside of the vehicle and advised him to stop kicking.

Ofc. Vanderhoof transported Jenkins to Lower Keys Medical Hospital as I followed for any assistance needed.

My BWC was active during the incident.
