A RESOLUTION OF THE CITY COMMISSION OF THE CITY KEY WEST, FLORIDA, RESCINDING RESOLUTION 14-084, IN ORDER TO RESCIND THE AWARD OF BID TO T. MAC WILDER & ASSOCIATES; AWARDING THE BID OF JSM SERVICES, INC. TO THE TRUMAN ANNEX SPORTS FIELD ACCORDANCE WITH THE TERMS SPECIFIED IN ITB AMOUNT NOT #14-011 IN AN \$118,090.00; AUTHORIZING THE CITY MANAGER TO SUBSTANTIAL ENTER INTO A CONTRACT IN CONTRACT DOCUMENTS CONFORMANCE WITH THE CONTAINED IN THE BID PACKAGE ON BEHALF OF THE CITY OF KEY WEST; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on February 27, 2014 two bids were opened in response to ITB #14-011, for Resod of the Truman Annex Sports Field, and both of the bids were responsive; and

WHEREAS, in Resolution 14-084 the City Commission awarded the bid to T. Mac Wilder & Associates, LLC, however, the vendor withdrew from the project; and

WHEREAS, the bid of JSM Services, Inc. is the next lowest responsive bid, and City staff recommends award of the bid accordingly; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That Resolution No. 14-011 is hereby rescinded.

Section 2: That the bid of **JSM Services**, **Inc**. for the Resod of the Truman Annex Sports Field in accordance with the terms specified in ITB #14-011 is hereby awarded in an amount not to exceed \$118,090.00.

Section 3: That necessary allocations of funds within account 101-4303-543-63 are hereby authorized.

Section 4: That the City Manager is authorized to execute a contract in substantial conformance with the contract documents contained within the bid package on behalf of the City of Key West upon the advice and consent of the City Attorney.

Section 5: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
