Action Statement

This resolution extends the respective City of Key West General Architectural Services Contracts for Salz-Michelson Architects and Hayes/Cumming Architects for two (2) years. This extension allows these firms to continue providing services to the City for ongoing projects. This resolution authorizes the City Manager to execute the contract extensions.

Background

Both architectural firms were awarded three (3) year General Architectural Services contracts by Resolution 12-220 in August 2012. Salz-Michelson Architects currently provides services to the City for the Community Services Building Project (FM1201). This project is on-hold awaiting further direction from the City Commission for location of an annex facility. Hayes/Cumming Architects currently provides services to the City for the Frederick Douglas Gym Repair Project (PR1203). This project is currently under design with construction anticipated to commence late Fall 2015.

Current agreements for both firms expire during August 2015.

Purpose and Justification

This resolution provides exercising a two (2) year, mutually agreed extension of the existing General Architectural Services contracts for both architectural firms to

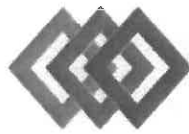

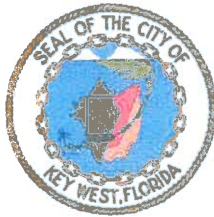

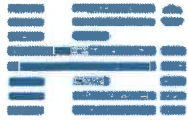
